1 AN ACT to create 20.235 (1) (kg), 20.292 (1) (fc), 20.505 (8) (hm) 13t., 38.04 (34)

and 39.381 of the statutes; **relating to:** grants to technical college and tribal

college students for apprenticeship expenses and making an appropriation.

Analysis by the Legislative Reference Bureau

This bill creates grant programs under which the Technical College System Board and Higher Educational Aids Board may award grants of up to \$1,500 to technical college students and tribal college students, respectively, who have undertaken an apprenticeship program in conjunction with their course of instruction at the technical college or tribal college. These grants may be awarded only to pay for the students' actual materials expenses, such as the cost of tools, equipment, and clothing, associated with the apprenticeship program. Among the requirements for a student to be eligible for a grant, the student must be enrolled in the apprenticeship program in the semester in which the grant is made and in the following semester.

SECTION 6. 39.381 of the statutes is created to read:

6 **39.381** Apprenticeship grants for tribal college students. (1) In this 7 section:

- (a) "Apprenticeship program" has the meaning given in s. 106.001 (4).
- 9 (b) "Tribal college" has the meaning given in s. 39.382 (1) (d).

10 (2) From the appropriation under s. 20.235 (1) (kg), the board shall award grants to students enrolled in tribal colleges who have undertaken an apprenticeship 11 12 program in conjunction with their course of instruction at the tribal college. Grants 13may be awarded only to pay for the students' actual materials expenses, such as the 14cost of tools, equipment, and clothing, associated with the apprenticeship program. 15Grants may not exceed \$1,500 per student or the student's actual materials 16 expenses, whichever is less.

(3) The board may not award a grant to a student under this section unless the student's application submitted to the board includes all of the following:
