**SENATE AMENDMENT 2,  
TO SENATE BILL 583**

January 29, 2020 - Offered by Senator MARKLEIN.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 3, line 9: after that line insert:

3 “**SECTION 3m.** 23.33 (1) (iq) of the statutes is repealed.”.

4 **2.** Page 3, line 22: delete “has” and substitute “has does not meet federal motor  
5 vehicle safety standards in effect on July 1, 2012; is not a golf cart, low-speed vehicle,  
6 dune buggy, mini-truck, or tracked vehicle; is designed to be used primarily off of a  
7 highway; and has, and was originally manufactured with,”.

8 **3.** Page 4, line 7: delete lines 7 to 11 and substitute:

9 “**SECTION 11e.** 23.33 (2) (b) 1. of the statutes is amended to read:

10 23.33 (2) (b) 1. Owned by the United States, or leased by a federal agency, state  
11 agency, political subdivision of the state, or another state or a political subdivision  
12 thereof, but if the exterior of the all-terrain vehicle or utility terrain vehicle shall

1 ~~display in a visible manner the name of the owner~~ displays the name of the  
2 government entity in a visible manner, except as provided in subd. 1m.

3 **SECTION 11m.** 23.33 (2) (b) 1m. of the statutes is created to read:

4 23.33 (2) (b) 1m. Owned or leased by a federal agency, state agency, political  
5 subdivision of the state, or another state or a political subdivision thereof and used  
6 for enforcement purposes.

7 **SECTION 11s.** 23.33 (2) (b) 4. of the statutes is repealed.

8 **SECTION 11u.** 23.33 (2j) (e) of the statutes is amended to read:

9 23.33 (2j) (e) An all-terrain vehicle or a utility terrain vehicle that is registered  
10 under sub. (2) (a) or an all-terrain vehicle or utility terrain vehicle that is exempt  
11 from registration under sub. (2) (b) 1., 1m., 3., or 3m., ~~or 4.~~ is exempt from having a  
12 nonresident trail pass or temporary trail use receipt displayed as required under par.  
13 (b). The department may promulgate a rule to exempt all-terrain vehicles and  
14 utility terrain vehicles that are exempt from registration under sub. (2) (b) 5. from  
15 having nonresident trail passes or temporary trail use receipts displayed as required  
16 under par. (b) or may promulgate a rule to exempt owners of such vehicles from  
17 having to pay any applicable nonresident trail pass fee.”.

18 **4.** Page 6, line 1: delete “flashing” and substitute “flashing, oscillating, or  
19 rotating”.

20 **5.** Page 7, line 9: delete “shall” and substitute “or white lamp visible from  
21 directly behind may”.

22 **6.** Page 7, line 14: delete “lighted during hours of darkness” and substitute  
23 “lighted”.

24 **7.** Page 10, line 11: after that line insert:
