**ASSEMBLY AMENDMENT 1,  
TO ASSEMBLY BILL 1042**

February 16, 2024 - Offered by Representative RODRIGUEZ.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 23, line 10: after that line insert:

3 “5. If a pupil receives virtual instruction from the private school, any individual  
4 providing educational services to the pupil in the pupil’s home, other than an  
5 individual for whom the private school is required to conduct a criminal background  
6 investigation under par. (d), is not subject to the requirements under subd. 1. or 4.”.

7 **2.** Page 23, line 18: after “(n)” insert “1.”.

8 **3.** Page 23, line 22: delete “1.” and substitute “a.”.

9 **4.** Page 23, line 23: delete “2.” and substitute “b.”.

10 **5.** Page 23, line 24: delete “3.” and substitute “c.”.

11 **6.** Page 23, line 25: delete “4.” and substitute “d.”.

12 **7.** Page 24, line 1: delete “5.” and substitute “e.”.

- 1           **8.** Page 24, line 2: delete “6.” and substitute “f.”
- 2           **9.** Page 24, line 2: after that line insert:
- 3           “2. Subdivision 1. does not apply if offering the virtual instruction to pupils is
- 4           incidental.”.
- 5           **10.** Page 93, line 24: after “INSTRUCTION.” insert “(a)”.
- 6           **11.** Page 94, line 3: delete “(a)” and substitute “1.”.
- 7           **12.** Page 94, line 4: delete “(b)” and substitute “2.”.
- 8           **13.** Page 94, line 5: delete “(c)” and substitute “3.”.
- 9           **14.** Page 94, line 6: delete “(d)” and substitute “4.”.
- 10          **15.** Page 94, line 7: delete “(e)” and substitute “5.”.
- 11          **16.** Page 94, line 8: delete “(f)” and substitute “6.”.
- 12          **17.** Page 94, line 8: after that line insert:
- 13          “(b) Paragraph (a) does not apply if offering the virtual instruction to pupils is
- 14          incidental.”.
- 15          **18.** Page 95, line 6: after that line insert:
- 16          “**SECTION 226m.** 118.81 (5) of the statutes is created to read:
- 17          118.81 (5) VIRTUAL INSTRUCTION. If a pupil receives virtual instruction from a
- 18          participating private school, any individual providing educational services to the
- 19          pupil in the pupil’s home, other than an individual for whom the participating
- 20          private school is required to conduct a criminal background investigation under sub.
- 21          (4), is not subject to the requirements under sub. (1) or (3).”.
