- At the locations indicated, amend the bill as follows:

If a pupil receives virtual instruction from the private school, any individual providing educational services to the pupil in the pupil's home, other than an individual for whom the private school is required to conduct a criminal background investigation under par. (d), is not subject to the requirements under subd. 1. or 4.".

  - **3.** Page 23, line 22: delete "1." and substitute "a.".
