7	2. Page 3, line 25: after that line insert:
8	"Section 6m. 302.05 (3) (c) 1. of the statutes is amended to read:
9	302.05 (3) (c) 1. Except as provided in par. (d), if the department determines
10	that an eligible inmate serving the term of confinement in prison portion of a
11	bifurcated sentence imposed under s. 973.01 has successfully completed a substance

use disorder treatment program described in sub. (1) (am) or (b) or an employment

- readiness training program described in sub. (1) (c), the department shall inform the court that sentenced the inmate.".
 - **3.** Page 7, line 8: after that line insert:

"Section 14m. 973.01 (3g) of the statutes is amended to read:

973.01 (3g) Earned release program eligibility. When imposing a bifurcated sentence under this section on a person convicted of a crime other than a crime specified in ch. 940 or s. 943.02, 943.03, 943.04, 948.02, 948.025, 948.03, 948.05, 948.051, 948.055, 948.06, 948.07, 948.075, 948.08, 948.085, or 948.095, the court shall, as part of the exercise of its sentencing discretion, decide whether the person being sentenced is eligible or ineligible to participate in the earned release program under s. 302.05 (3) during the term of confinement in prison portion of the bifurcated sentence."
