ASSEMBLY AMENDMENT 1, TO ASSEMBLY BILL 467

October 30, 2023 - Offered by Representative Moses.

1	At the locations indicated, amend the bill as follows:
2	${f 1}_{f \cdot}$ Page 5, line 14: delete "under this section" and substitute "from the
3	department. The department may make announced and unannounced inspections
4	and complaint investigations of crisis urgent care and observation facilities as it
5	deems necessary, at reasonable times and in a reasonable manner.".
6	2. Page 6, line 18: delete lines 18 to 21 and substitute:
7	"1. Accept referrals for crisis services for adults and, if applicable, for youth,
8	including any of the following:
9	a. Involuntary patients brought under s. 51.15.
10	b. Voluntary patients for services arriving as walk-ins or brought by law
11	enforcement, emergency medical responders or emergency medical services
12	practitioners, or county crisis personnel.".
13	3. Page 7, line 7: after "practitioners," insert "physician assistants,".

1	4. Page 8, line 24: after "joint committee on finance" insert "and to the chief
2	clerk of each house of the legislature, for distribution to the appropriate standing
3	committees under s. 13.172 (3),".
4	5. Page 9, line 9: after "times" insert ", including for admission, treatment,
5	discharge, and any other significant aspect of services provided by a crisis urgent
6	care and observation facility".
7	6. Page 9, line 19: after "times of day" insert ", including through the use of
8	telehealth".
9	7. Page 9, line 22: after that line insert:
10	"12. The number of repeat clients and readmissions.
11	13. Utilization of follow-up services, as applicable.
12	14. The number of transfers to other facilities, including Winnebago Mental
13	Health Institute, hospitals, or other facilities.
14	15. A description of any injuries, assaults, or other safety-related incidents.
15	16. A breakdown of funding, including the amounts and sources of funding.
16	17. The number of clients served.
17	18. Facility capacity, specifically the number of staffed beds.
18	(f) Notwithstanding the certification requirements set forth under this
19	subsection, any facility that before the effective date of this paragraph [LRB
20	inserts date], is providing crisis intervention services that on or after the effective
21	date of this paragraph [LRB inserts date], would otherwise require certification
22	as a crisis urgent care and observation facility may on and after the effective date of
23	this paragraph [LRB inserts date], continue to provide these services without
24	obtaining certification from the department under this subsection.".

8. Page 11, line 20: after "interfacility transfers" insert "initiated at a crisis
 urgent care and observation facility".

9. Page 12, line 2: after "availability" insert "in a crisis urgent care and observation facility".

10. Page 12, line 23: after "requirements" insert ", including policies to ensure
the availability of adequate in-person and on-site care".
