13	7. Page 3, line 20: after that line insert:
14	"(bm) "Fees" means "fees," as defined in s. 38.24 (7) (a) 1p., and the amount
15	charged to a resident student for activity, incidental, and vocational-adult seminar
16	and workshop fees under s. 38.14 (9).".
17	8. Page 3, line 21: delete "cost of attendance" and substitute "direct costs".
18	9. Page 4, line 3: delete the material beginning with "to meet" and ending with
19	"gift aid." on line 5 and substitute "that the entity awarding the gift aid has
20	designated as a last-dollar scholarship.".
21	10. Page 5, line 4: delete that line and substitute:

"(am) "Direct costs" means costs that a private higher education institution
 bills directly to a student, including tuition, institutional fees, and if applicable room
 and board.".

11. Page 5, line 6: delete "1087nn." and substitute "1087nn, except that, upon
implementation of section 702 of the FAFSA Simplification Act, Title VII of Division
FF of P.L. 116-260, as affected by section 102 of the FAFSA Simplification Act
Technical Corrections Act, Division R of P.L. 117-103, "expected family contribution"
shall be determined consistently with requirements for determining the student aid
index under 20 USC ch. 28.".

10 **12.** Page 5, line 13: delete "cost of attendance" and substitute "direct costs".

13. Page 5, line 19: delete the material beginning with "to meet" and ending
with "gift aid." on line 21 and substitute "that the entity awarding the gift aid has
designated as a last-dollar scholarship.".
