## SENATE AMENDMENT 1, TO SENATE BILL 791

January 9, 2024 - Offered by Senator MARKLEIN.

1	At the locations indicated, amend the bill as follows:
2	<b>1.</b> Page 3, line 10: delete lines 10 to 13 and substitute:
3	"(2) (a) Except as provided in par. (b), no state agency may own, operate, or
4	lease an electric vehicle charging station containing a Level 1, Level 2, or Level 3
5	charger unless the charger is not available to the public and is used solely to charge
6	vehicles owned or leased by a state agency.
7	(b) A state agency may own, operate, manage, or lease an electric vehicle
8	charging station at which a Level 1 charger or Level 2 charger is available to the
9	public if the state agency makes all Level 1 chargers or Level 2 chargers available
10	for public use free of any charge.
11	(3) Notwithstanding sub. (2), a state agency may authorize an electric provider,
12	as defined in s. 16.957 (1) (f), or a person described in s. 196.01 (5) (b) 8. to own and
13	operate an electric vehicle charging station at which a Level 1 charger, Level 2

charger, or Level 3 charger is available to the public on property owned by the state
agency.".

15	"(3) At the time that the department approves a registration under this section,
16	the department shall notify the electric provider, as defined in s. 16.957 (1) (f),
17	serving the area in which the electric vehicle charging station is located of the
18	approved registration for the electric vehicle charging station.".
19	${f 12.}$ Page 8, line 5: delete ", for compensation, by" and substitute "by a Level
20	3 charger of".
21	<b>13.</b> Page 8, line 7: after "by" insert "a Level 3 charger of".
22	<b>14.</b> Page 8, line 8: after that line insert:

1	"(c) The tax imposed under this section applies regardless of whether or not a
2	person holding a registration under s. 77.9971 charges for the electricity delivered
3	or placed by the person's Level 3 charger at an electric vehicle charging station.".
4	15. Page 8, line 11: delete "permit" and substitute "registration".
5	<b>16.</b> Page 8, line 15: delete "permit" and substitute "registration".
6	<b>17.</b> Page 8, line 20: delete "permit" and substitute "registration".
7	18. Page 8, line 22: after "by" insert "the Level 3 chargers of".
8	<b>19.</b> Page 9, line 1: delete "permit" and substitute "registration".
