1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** At the appropriate places, insert all of the following:

3 “**SECTION 1.** 15.145 (title) of the statutes is amended to read:

4 **15.145 (title) Same; attached boards, commissions, ~~and~~ councils, and**
5 **offices.**

6 **SECTION 2.** 15.145 (7) of the statutes is created to read:

7 15.145 (7) OFFICE OF THE OMBUDSPERSON FOR CORRECTIONS. There is created
8 an office of the ombudsperson for corrections, attached to the department of
9 corrections under s. 15.03. The office shall be under the direction and supervision
10 of an ombudsperson who shall be nominated by the governor, with the advice and

consent of three-fourths of members elected to the senate appointed, and may be removed only by the governor for just cause.

SECTION 3. 20.005 (3) (schedule) of the statutes: at the appropriate place, insert the following amounts for the purposes indicated:

SECTION 4. 20.410 (4) of the statutes is created to read:

20.410 (4) OFFICE OF THE OMBUDSPERSON FOR CORRECTIONS. (a) *General program operations.* The amounts in the schedule for the general program operations of the office of the ombudsperson for corrections.

(i) *Gifts and grants.* All moneys received from gifts and grants to carry out the purposes for which made.

(k) *Interagency and intra-agency assistance.* All moneys received from the department or any other state agency to carry out the purposes for which received.

(m) *Federal aid.* All moneys received as federal aid as authorized by the governor under s. 16.54 to carry out the purposes for which received.

1 **SECTION 5.** 20.923 (6) (bn) of the statutes is created to read:

2 20.923 **(6)** (bn) Corrections, department of: ombudsperson of the office of the
3 ombudsperson for corrections.

4 **SECTION 6.** 230.08 (2) (ym) of the statutes is created to read:

5 230.08 **(2)** (ym) The ombudsperson of the office of the ombudsperson for
6 corrections.

7 **SECTION 7.** 301.55 of the statutes is created to read:

8 **301.55 Office of the ombudsperson for corrections. (1) DEFINITIONS.**

9 In this section:

10 (a) “Office” means the office of the ombudsperson for corrections.

11 (b) “Ombudsperson” means the ombudsperson of the office.

12 **(2) STAFF.** The ombudsperson may appoint, in the classified service, one
13 deputy ombudsperson of the office, and employees for the office to complete the
14 ombudsperson’s duties described under this section. The ombudsperson may
15 delegate to the deputy ombudsperson or other employees of the office any of the
16 ombudsperson’s authority or duties except those described under subs. (5) (b) and
17 (7) (b).

18 **(3) POWERS.** The ombudsperson may do all of the following:

19 (a) Investigate, upon a complaint or upon personal initiative, any matter
20 described under sub. (4).

21 (b) Determine the scope and manner of investigations to be made.

22 (c) Enter and inspect, at any time, premises within the control of the
23 department.

24 (d) Examine records and documents in the possession of the department,

1 including corrections and detention data and medical data maintained by the
2 department and classified as private or confidential data on individuals when
3 access to the data is necessary for the ombudsperson to perform the powers
4 authorized under this subsection.

5 (e) Subpoena witnesses and the production of books, papers, records, and
6 documents material to an investigation conducted by the office.

7 (f) Attend any proceedings and deliberations relating to the granting or
8 revocation of parole, extended supervision, or probation.

9 **(4) INVESTIGATIONS.** The ombudsperson may investigate any of the following:

10 (a) Complaints regarding state correctional institutions and abuse, unfair
11 acts, and violations of rights of prisoners and juveniles.

12 (b) The policies or practices of the department.

13 (c) Any action by the department that may be contrary to law or rule.

14 (d) Any other action by the department that has been alleged to be
15 unreasonable, unfair, oppressive, or inconsistent with any policy or judgment of the
16 department.

17 (e) Procedures and practices that may lessen the risk that objectionable
18 actions by the department may occur in the future.

19 **(5) COMPLAINTS.** (a) The ombudsperson shall create a complaint form and
20 provide sufficient blank copies of the form and self-sealing envelopes to state
21 correctional institutions for distribution to prisoners and juveniles. Blank copies of
22 the form and self-sealing envelopes shall be placed in locations where prisoners and
23 juveniles regularly visit, such as a common area or library, and shall be provided

1 upon request to a prisoner or juvenile. The department shall also make the form
2 available on its website.

3 (b) An operator of a state correctional institution shall immediately forward a
4 complaint form described under par. (a) that has been completed by a prisoner or
5 juvenile to the office. No individual other than an authorized employee of the office
6 may open an envelope that contains a complaint form.

7 (c) The ombudsperson shall review each complaint form received under par.
8 (b) and determine whether to make a recommendation regarding the complaint
9 directly to the state correctional institution where the prisoner or juvenile is
10 housed, the governor, the legislature, or other party, or make no recommendation.

11 (d) No operator of a state correctional institution may open and preview or
12 screen mail addressed from the office to a prisoner or juvenile residing at the state
13 correctional institution unless the operator has reason to believe that the mail
14 contains contraband or is not a document from the office. If the operator has reason
15 to believe that the mail contains contraband or is not a document from the office,
16 the operator may open and inspect the mail in the presence of the prisoner or
17 juvenile to whom it was addressed, but may inspect the document only to the extent
18 necessary to determine whether it contains contraband or is not a document from
19 the office. The operator may read the mail only if, after inspection, the operator has
20 reason to believe it not a document from the office.

21 **(6) DISCLOSURES.** Information in the possession of the office that relates to a
22 client, complaint, or investigation of the office may be disclosed only at the
23 discretion of the ombudsperson or his or her designated representative. A
24 disclosure of information under this subsection relating to a client, named witness,

1 or a prisoner or juvenile who is not a client may be made only if one of the following
2 applies:

3 (a) The disclosure is authorized in writing by the client, named witness,
4 prisoner, or juvenile or his or her legal guardian, if applicable.

5 (b) The disclosure is made pursuant to a lawful order of a court of competent
6 jurisdiction.

7 **(7) REPORTS.** (a) If the ombudsperson determines to make a recommendation
8 under sub. (5) (c) directly to the state correctional institution where the prisoner or
9 juvenile is housed, the warden or superintendent of the state correctional
10 institution shall respond within 30 days. The warden or superintendent shall
11 include in the response what actions the warden or superintendent is taking as a
12 result of the recommendations of the ombudsperson and why the warden or
13 superintendent is taking those actions or not taking actions.

14 (b) If the ombudsperson has reason to believe that any public official or
15 employee has acted in a manner warranting criminal or disciplinary proceedings,
16 the ombudsperson may refer the matter to the appropriate authorities.

17 (c) The ombudsperson shall, at the request of the governor at any time, report
18 to the governor on any matter over which the ombudsperson has authority.

19 (d) On or before December 31 of each year, the ombudsperson shall submit to
20 the governor, the chief clerk of each house of the legislature for distribution to the
21 legislature under s. 13.172 (2), and the secretary of corrections a report of the
22 ombudsperson's findings and recommendations for improvements to policies and
23 practices at state correctional institutions and the results of the ombudsperson's
24 investigations conducted under sub. (4).

1 **SECTION 9108. Nonstatutory provisions; Corrections.**

2 (1) POSITION AUTHORITY FOR THE OFFICE OF THE OMBUDSPERSON FOR
3 CORRECTIONS. On the effective date of this subsection, the authorized FTE
4 positions for the department of corrections are increased by 11.0 GPR positions, to
5 be funded from the appropriation under s. 20.410 (4) (a), to provide one
6 ombudsperson for corrections and 10 program and policy chief positions for the
7 office of the ombudsperson for corrections.”.

8 **2.** At the appropriate places, insert all of the following:

9 **“SECTION 8.** 100.2091 of the statutes is created to read:

10 **100.2091 Broadband; discrimination prohibited.** (1) No broadband
11 service provider may deny access to broadband service to any group of potential
12 residential customers because of the race or income of the residents in the area in
13 which the group resides.

14 (2) It is a defense to an alleged violation of sub. (1) based on income if, no later
15 than 3 years after the date on which the broadband service provider began
16 providing broadband service in this state, at least 30 percent of the households with
17 access to the broadband service provider’s broadband service in the area in which a
18 group of potential residential customers resides are low-income households.

19 (3) The department may enforce this section and may promulgate rules to
20 implement and administer this section, including rules that define low-income
21 households, and to align department rules with federal communications
22 commission broadband rules. The department of justice may represent the
23 department in an action to enforce this section. If the court finds that a broadband

1 service provider has not complied with this section, the court shall order the
2 broadband service provider to comply with this section within a reasonable amount
3 of time and, notwithstanding s. 814.14 (1), shall award costs, including reasonable
4 attorney fees, to the department of justice.

5 (4) Any person that is affected by a failure to comply with this section may
6 bring an action to enforce this section. If a court finds that a broadband service
7 provider has not complied with this section, the court shall order the broadband
8 service provider to comply with this section within a reasonable amount of time
9 and, notwithstanding s. 814.14 (1), shall award costs, including reasonable attorney
10 fees, to the person affected.

11 **SECTION 9.** 100.2092 of the statutes is created to read:

12 **100.2092 Broadband service subscriber rights. (1) RIGHTS. (a)** A
13 broadband service provider shall repair broadband service within 72 hours after a
14 subscriber reports a service interruption or requests the repair if the service
15 interruption is not the result of a major system-wide or large area emergency, such
16 as a natural disaster.

17 (b) Upon notification by a subscriber of a service interruption, a broadband
18 service provider shall give the subscriber a credit for one day of broadband service
19 if broadband service is interrupted for more than 4 hours in one day and the
20 interruption is caused by the broadband service provider.

21 (c) Upon notification by a subscriber of a service interruption, a broadband
22 service provider shall give the subscriber a credit for each hour that broadband

1 service is interrupted if broadband service is interrupted for more than 4 hours in
2 one day and the interruption is not caused by the broadband service provider.

3 (d) Prior to entering into a service agreement with a subscriber, a broadband
4 service provider shall disclose that a subscriber has a right to a credit for notifying
5 the broadband service provider of a service interruption.

6 (e) A broadband service provider shall provide broadband service that
7 satisfies minimum standards established by the department by rule.

8 (f) A broadband service provider shall give a subscriber at least 30 days'
9 advance written notice before instituting a rate increase.

10 (g) A broadband service provider shall give a subscriber at least 7 days'
11 advance written notice of any scheduled routine maintenance that causes a service
12 slowdown, interruption, or outage.

13 (h) A broadband service provider shall give a subscriber at least 10 days'
14 advance written notice of disconnecting service, unless the disconnection is
15 requested by the subscriber.

16 (i) Prior to entering into a service agreement with a subscriber, a broadband
17 service provider shall disclose the factors that may cause the actual broadband
18 speed experience to vary, including the number of users and device limitations.

19 (j) A broadband service provider shall provide broadband service to a
20 subscriber as described in point-of-sale advertisements and representations made
21 to the subscriber.

22 (k) A broadband service provider shall give a subscriber at least 10 days'

1 advance written notice of a change in a factor that may cause the originally
2 disclosed broadband speed experience to vary.

3 (L) A broadband service provider shall allow a subscriber to terminate a
4 contract and receive a full refund without fees if the provider sells a service that
5 does not satisfy the requirements established under par. (e) and the broadband
6 service provider does not satisfy the requirements established under par. (e) within
7 one month of written notification from the subscriber.

8 (2) ADVERTISING. A broadband service provider shall disclose the factors that
9 may cause the actual broadband speed experience of a subscriber to vary, including
10 the number of users and device limitations, in each advertisement of the speed of
11 the provider's service, including in all of the following types of advertisements:

12 (a) Television and other commercials.

13 (b) Internet and email advertisements.

14 (c) Print advertisements and bill inserts.

15 (d) Any other advertising method or solicitation for the sale of new or
16 upgraded broadband service.

17 (3) RULES. The department may promulgate rules to implement and
18 administer this section, including rules to align department rules with federal
19 communications commission broadband rules.

20 (4) PENALTY; ENFORCEMENT. (a) A person who violates this section may be
21 required to forfeit not more than \$1,000 for each violation and not more than
22 \$10,000 for each occurrence. Failure to give a notice required under sub. (1) (f) to
23 more than one subscriber shall be considered one violation.

1 (b) The department or a district attorney may institute civil proceedings
2 under this section.

3 **SECTION 10.** 165.25 (4) (ar) of the statutes is amended to read:

4 165.25 (4) (ar) The department of justice shall furnish all legal services
5 required by the department of agriculture, trade and consumer protection relating
6 to the enforcement of ss. 91.68, 93.73, 100.171, 100.173, 100.174, 100.175, 100.177,

13 Internet service in this state unless the person registers with the commission.

15 **Protection.**

16 (1) SUBSCRIBERS PERMITTED TO TERMINATE BROADBAND CONTRACTS. The
17 treatment of s. 100.2092 (1) (L) first applies to a contract that is entered into,
18 renewed, or modified on the effective date of this subsection.

19 **SECTION 9436. Effective dates; Public Service Commission.**

20 (1) INTERNET SERVICE PROVIDER REGISTRATION REQUIREMENT. The treatment
21 of s. 196.5048 takes effect on January 1, 2026.”.

1 (1) HOTLINE FOR EMPLOYERS. In the schedule under s. 20.005 (3) for the
2 appropriation to the department of workforce development under s. 20.445 (1) (a),
3 the dollar amount for fiscal year 2025-26 is increased by \$64,000 to increase the
4 authorized FTE positions for the department by 1.0 GPR employment and training
5 specialist position to staff the hotline under s. 106.361. In the schedule under s.
6 20.005 (3) for the appropriation to the department of workforce development under
7 s. 20.445 (1) (a), the dollar amount for fiscal year 2026-27 is increased by \$82,800 to
8 provide funding for the position authorized under this subsection.

9 (2) CAREER NAVIGATORS. In the schedule under s. 20.005 (3) for the
10 appropriation to the department of workforce development under s. 20.445 (1) (a),
11 the dollar amount for fiscal year 2025-26 is increased by \$710,600 to increase the
12 authorized FTE positions for the department by 11.0 GPR employment and
13 training specialist positions to provide career navigator services. In the schedule
14 under s. 20.005 (3) for the appropriation to the department of workforce
15 development under s. 20.445 (1) (a), the dollar amount for fiscal year 2026-27 is
16 increased by \$910,800 to provide funding for the positions authorized under this
17 subsection.

21 fiscal year 2025-26 is increased by \$6,356,900 to increase the authorized FTE
22 positions for the department by 1.15 GPR vocational rehabilitation services
23 positions and provide funding for those services. In the schedule under s. 20.005 (3)
24 for the appropriation to the department of workforce development under s. 20.445

1 (5) (a), the dollar amount for fiscal year 2026-27 is increased by \$9,059,000 to
2 provide funding for the positions and services authorized under this subsection.

3 (b) *Federal funding*. In the schedule under s. 20.005 (3) for the appropriation
4 to the department of workforce development under s. 20.445 (5) (n), the dollar
5 amount for fiscal year 2025-26 is increased by \$287,900 to increase the authorized
6 FTE positions for the department by 3.85 FED vocational rehabilitation services
7 positions and provide funding for those services. In the schedule under s. 20.005 (3)
8 for the appropriation to the department of workforce development under s. 20.445
9 (5) (n), the dollar amount for fiscal year 2026-27 is increased by \$20,564,300 to

17 fiscal year 2026-27 is increased by \$200,000 to provide increased funding for the
18 technical education equipment grants under s. 106.275.”.

24 authorized FTE positions in the department by 12.0 GPR positions for a central

2 appropriation to the department of corrections under s. 20.410 (1) (a), the dollar
3 amount for fiscal year 2026-27 is increased by \$2,209,700 to provide funding for the
4 positions authorized under this subsection.”.

11 or for whom the respondent is or was the foster parent or other physical custodian
12 described in s. 48.62 (2).

13 (b) "Firearms dealer" has the meaning given in s. 175.35 (1) (ar).

14 (c) "Law enforcement officer" has the meaning given in s. 165.85 (2) (c).

15 **(2)** COMMENCEMENT OF ACTION AND RESPONSE. No action under this section
16 may be commenced by complaint and summons. An action under this section may
17 be commenced only by a petition described under sub. (4) (a).

18 **(2m)** PROCEDURE. Procedure for an action under this section is as follows:

19 (a) If the petitioner requests an extreme risk protection temporary restraining
20 order, the court shall consider the request as provided under sub. (2t). If the court
21 issues a temporary restraining order, the court shall set forth the date, which must
22 be within 14 days of issuing the temporary restraining order, for the hearing on the
23 injunction and shall forward a copy of the temporary restraining order, the

1 injunction hearing date, and the petition to the appropriate law enforcement agency
2 with jurisdiction over the respondent's residence. The law enforcement agency
3 shall immediately, or as soon as practicable, serve it on the respondent. If personal
4 service cannot be effected upon the respondent, the court may order other

8 temporary restraining order, the respondent shall be served notice of the petition by

12 respondent and of the petitioner, and, if known, notice of the date, time, and place of

19 respondent to surrender all firearms in the respondent's possession if all of the
20 following occur:

21 1. A petitioner files a petition alleging the elements under sub. (4) (a), and
22 requests a temporary restraining order. The petition requesting a temporary
23 restraining order shall be heard by the court in an expedited manner. The court

1 shall examine under oath the petitioner and any witness the petitioner may
2 produce or may rely on an affidavit submitted in support of the petition.

3 2. The judge finds all of the following:

4 a. Substantial likelihood that the petition for an injunction will be successful.

5 b. Good cause to believe that there is an immediate and present danger that
6 the respondent may injure themselves or another person if the respondent possesses a
7 firearm and that waiting for the injunction hearing may increase the immediate
8 and present danger.

9 (b) A temporary restraining order issued under this subsection shall remain
10 in effect until a hearing is held on issuance of an injunction under sub. (3). Notice
11 need not be given to the respondent before issuing a temporary restraining order
12 under this subsection. A temporary restraining order may be entered against only
13 the respondent named in the petition and may not be renewed or extended.

4 subsection a receipt indicating that the respondent surrendered, transferred, or
5 sold the firearms. The receipt must include the date on which each firearm was

7 of each firearm and must be signed by either the law enforcement officer to whom
8 the firearm was surrendered or the firearms dealer to whom the firearm was

1 substantially likely to injure themselves or another person if the respondent possesses
2 a firearm.

3 (b) The judge may enter an injunction against only the respondent named in

5 (c) 1. Unless a judge vacates the injunction under par. (d), an injunction under
6 this subsection is effective for a period determined by the judge that is no longer
7 than one year.

8 2. When an injunction expires, the court shall extend the injunction, upon
9 petition, for up to one year if the judge finds by clear and convincing evidence that
10 the respondent is still substantially likely to injure themselves or another person if the
11 respondent possesses a firearm.

13 may request in writing a judge to vacate the injunction one time during any
14 injunction period. If a respondent files a request under this paragraph, the
15 petitioner shall be notified of the request before the judge considers the request.

4 3. That the respondent is substantially likely to injure themselves or another
5 person if the respondent possesses a firearm.

6 4. If the petitioner knows, the number, types, and locations of any firearms
7 that the respondent possesses.

8 5. If requesting a temporary restraining order, evidence of an immediate and
9 present danger that the respondent may injure themselves or another person if the
10 respondent possesses a firearm and that waiting for the injunction hearing may
11 increase the immediate and present danger.

12 (b) The clerk of the circuit court shall provide simplified forms to help a
13 person file a petition.

14 (c) Only the following persons may file a petition under this section:

15 1. A law enforcement officer.

17 **(5) ENFORCEMENT ASSISTANCE.** (a) 1. If a temporary restraining order is
18 issued under sub. (2t) or an injunction is issued, extended, or vacated under sub. (3),
