22 of abuse of alcohol or other drugs only if the veteran is participating in an alcohol
23 and other drug abuse treatment program that is approved by the department. No

1 income available to meet basic subsistence needs or if the veteran is eligible to
2 receive aid from other sources to meet those needs. When determining the assets
3 available to the veteran, the department may not include the first \$50,000 of cash
