If the individual has 2 qualifying children who have the same principal 7 place of abode as the individual, 25 percent. 8 3. If the individual has 3 or more qualifying children who have the same 9 principal place of abode as the individual, 34 percent. 10 **SECTION 3.** 73.03 (73) (f) 1. of the statutes is amended to read: 11 Subject to subd. 2., for taxable years beginning after 73.03 (**73**) (f) 1. 12December 31, 2020, the department shall make the pilot program described under 13par. (b) permanent and applicable to all eligible claimants of the earned income tax 14 credit under s. 71.07 (9e) (aj), based on the specifications described under pars. (b) 15and (c) 2.". 16 (END)
