20 (b) “Health care provider” means a physician, surgeon, physician assistant, or
21 nurse practitioner.

22 (c) “Parkinsonism” means a condition that causes a combination of the
23 movement abnormalities seen in Parkinson’s disease, including tremor at rest, slow
24 movements, muscle rigidity, stooped posture, or unsteady or shuffling gait, which

1 often overlap with and can evolve from what appears to be Parkinson's disease.
2 "Parkinsonism" includes multiple system atrophy, dementia with Lewy bodies,
3 corticobasal degeneration, and progressive supranuclear palsy.

4 (d) "Parkinson's disease" means a chronic and progressive neurologic disorder
5 resulting from deficiency of the neurotransmitter dopamine as the consequence of
6 specific degenerative changes in the basal ganglia, which is characterized by tremor
7 at rest, slow movements, muscle rigidity, stooped posture, and unsteady or
8 shuffling gait.

9 (2) CONSULTATION BY THE DEPARTMENT OF HEALTH SERVICES. The
10 department of health services may do all of the following:

11 (a) Assist the department in the establishment and maintenance of a
12 Parkinson's disease registry, as provided under sub. (3).

13 (b) Make recommendations to the department on the data to be collected in
14 the Parkinson's disease registry.

15 (c) Advise the department on the Parkinson's disease registry.

16 (d) Make recommendations to the department on the best practices for the
17 establishment of the Parkinson's disease registry under sub. (3).

18 (3) PARKINSON'S DISEASE REGISTRY. (a) By no later than the first day of the
19 19th month beginning after the effective date of this paragraph [LRB inserts
20 date], the department shall, after consultation with the department of health
21 services, establish and maintain a Parkinson's disease registry for the collection,
22 storage, and dissemination of information about the incidence and prevalence of
23 Parkinson's disease and parkinsonisms in this state.

1 (b) The department shall collect and store in the Parkinson's disease registry
2 data reported under s. 255.18 (2) by health care providers and health care facilities.

3 (c) The department shall prescribe the format for reporting information to the
4 department under s. 255.18 (2).

5 (d) The department shall create, and regularly review and revise, a list of
6 information that health care providers and health care facilities must report,
7 subject to s. 255.18 (2) (d), to the department under s. 255.18 (2). The list shall
8 include the incident of a patient's Parkinson's disease or parkinsonism; necessary
9 triggering diagnostic conditions, consistent with the latest version of the
10 International Statistical Classification of Diseases and Related Health Problems;
11 resulting case data on issues including diagnosis, treatment, and survival; and
12 patient demographic information, including age, gender, and race. The Board of
13 Regents of the University of Wisconsin System may promulgate rules to implement
14 and administer this paragraph.

15 (e) The University of Wisconsin-Madison may enter into agreements in order
16 for the department to securely and confidentially receive information from data
17 reporting entities and their associated electronic medical records vendors related to
18 Parkinson's disease testing, diagnosis, and treatment.

19 (f) 1. The University of Wisconsin-Madison may enter into agreements in
20 order for the department to disclose data collected in the Parkinson's disease
21 registry to another state's Parkinson's disease registry, a federal Parkinson's
22 disease control agency, a local health officer, or a researcher who proposes to
23 conduct research on Parkinson's disease.

24 2. Before disclosing data containing confidential information to an entity

1 under subd. 1., the University of Wisconsin-Madison shall require the entity to
2 specify the purpose for the requested disclosure, agree in writing to maintain the
3 confidentiality of the information and, if the entity is a researcher, provide all of the
4 following to the University of Wisconsin-Madison:

5 a. A written protocol to perform research.

6 b. Documentation of approval of the research protocol by an institutional
7 review board of a domestic institution that has a federalwide assurance approved by
8 the office for human research protections of the federal department of health and
9 human services.

10 c. Documentation that demonstrates to the University of Wisconsin-
11 Madison's satisfaction that the researcher has established procedures and has the
12 capability to maintain the confidentiality of the information.

13 (4) WEBSITE. (a) By no later than the first day of the 19th month beginning
14 after the effective date of this paragraph [LRB inserts date], the department
15 shall establish and maintain a public website dedicated to the Parkinson's disease
16 registry under sub. (3). The department shall include on the website all of the
17 following:

18 1. Downloadable annual reports on the incidence and prevalence of
19 Parkinson's disease in this state.

20 2. Relevant data, as determined by the department, about Parkinson's
21 disease and parkinsonisms for the 5-year period prior to the effective date of this
22 subdivision [LRB inserts date].

23 3. Other helpful resources about Parkinson's disease, as determined by the
24 department.

1 (b) By no later than January 1 of each year, the department shall update the
2 information specified in par. (a) 1. on the website maintained under par. (a).

3 (c) The department shall publish on its website notice of the reporting
4 requirement under s. 255.18 no fewer than 90 days before the reporting
5 requirement takes effect.

6 **(5) CONFIDENTIALITY.** (a) Any information reported to the department under
7 s. 255.18 (2) that could identify an individual who is the subject of the report or a
8 health care provider submitting the report is confidential.

9 (b) To ensure privacy, the department shall use a coding system for the data
10 stored in the Parkinson's disease registry that removes any identifying information
11 about an individual who is the subject of a report under s. 255.18.

12 (c) 1. If the University of Wisconsin-Madison or the department discloses
13 confidential information as authorized under sub. (3) (f), the University of
14 Wisconsin-Madison or department may include in the disclosure only the
15 information necessary for the purpose specified under sub. (3) (f) 2.

16 2. A person who obtains confidential information from the University of
17 Wisconsin-Madison or the department under sub. (3) (f) may use the information
18 only for the purpose specified under sub. (3) (f) 2. and may not redisclose the
19 information.

20 (d) The department shall maintain an accurate record of all persons given
21 access to confidential information under this section. The record shall include all of
22 the following:

23 1. The name of the person authorizing access.

24 2. The title, address, and organizational affiliation of any person given access.

1 3. The dates of access.

2 4. The specific purpose for which the information is to be used.

3 (e) The department shall make the records maintained under par. (d)
4 available for public inspection during the department's normal operating hours.

5 (f) Confidential information under this section is not available for subpoena
6 and may not be disclosed, discoverable, or compelled to be produced in any civil,
7 criminal, administrative, or other proceeding. Confidential information under this
8 section is not admissible as evidence in any civil, criminal, administrative, or other
9 tribunal or court for any reason.
