TO SENATE BILL 45**

July 2, 2025 - Offered by Senators HESSELBEIN, SMITH, SPREITZER, DRAKE, L. JOHNSON, ROYS, CARPENTER, DASSLER-ALFHEIM, HABUSH SINYKIN, KEYESKI, LARSON, PFAFF, RATCLIFF and WALL.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** At the appropriate place, insert the schedule for s. 20.455 from 2025
3 Senate Bill 45 covering the department of justice.

4 **2.** At the appropriate place, insert all of the following:

10 or for whom the respondent is or was the foster parent or other physical custodian
11 described in s. 48.62 (2).

12 (b) "Firearms dealer" has the meaning given in s. 175.35 (1) (ar).

13 (c) "Law enforcement officer" has the meaning given in s. 165.85 (2) (c).

14 **(2)** COMMENCEMENT OF ACTION AND RESPONSE. No action under this section
15 may be commenced by complaint and summons. An action under this section may
16 be commenced only by a petition described under sub. (4) (a).

17 **(2m)** PROCEDURE. Procedure for an action under this section is as follows:

18 (a) If the petitioner requests an extreme risk protection temporary restraining
19 order, the court shall consider the request as provided under sub. (2t). If the court
20 issues a temporary restraining order, the court shall set forth the date, which must
21 be within 14 days of issuing the temporary restraining order, for the hearing on the
22 injunction and shall forward a copy of the temporary restraining order, the
23 injunction hearing date, and the petition to the appropriate law enforcement agency
