This proposed rule-making order will bring into conformity the issuance of camp physician or locum tenens licenses with the issuance of permanent licenses.

The Medical Examining Board has determined through its policies and procedures that camp physician or locum tenens license applications should be reviewed using the same process as permanent license applications.

TEXT OF RULE

SECTION 1. Med 4.03 is repealed.

SECTION 2. Med 4.06 is amended to read:

Med 4.06 <u>EXPIRATION AND RENEWAL</u>. A temporary camp physician or locum tenens license shall expire 90 days from the date of its issuance. For cause shown to the satisfaction of 2 officers of the board, the board, acting through such 2 officers, may renew such temporary license for additional periods of 90 days each, but no such license may be renewed more than 3 consecutive times.
