#### **ORDER**

#### **OF**





To create ElBd 1.655(1)(bm) and (5), relating to source identification in polls and surveys conducted for political purposes.

### **ANALYSIS:**

Statutory authority: ss.5.05(1)(f) and 227.11(2)(a)

Statutes interpreted: ss.11.01(16), 11.06(12), and 11.30(2), (4) and (5).

The rule provides that the source of any communication, including a telephone call, that has been paid for with money raised for political purposes – except a bona fide poll or survey which does not expressly advocate the election or defeat of a clearly identified candidate or a vote at a referendum – shall be identified during the course of, or at the end of, the communication. The Elections Board's action adds a new paragraph, (1)(bm), and a new subsection, (5), defining the term "political party" and establishing a special source identification for slate endorsements in political party communications.

Pursuant to the authority vested in the State of Wisconsin Elections Board by ss.5.05(1)(f) and 227.11(2)(a), Stats., the Elections Board hereby creates Rule ElBd 1.655(1)(bm) and (5) interpreting ss.11.01(16), 11.06(12), and 11.30(2), (4) and (5), Stats., as follows:

SECTION 1. ElBd. 1.655(1)(bm) and (5) are created to read:

- (1)(bm) "Political party" has the meaning provided in s.5.02(13), Stats.
- (5) If a political party makes a communication supporting the election of more than one candidate, the source identification for that communication shall be as follows:

"Paid for by the (name of party) Party as an in-kind contribution to the candidates named."
