

EXECUTIVE ORDER NO. 25

WHEREAS, the development of relevant training programs and the availability of adequately trained manpower are essential to the social and economic well-being of Wisconsin; and

WHEREAS, some areas of Wisconsin are lacking job opportunities while other areas are lacking a trained work force; and

WHEREAS, the expenditure of manpower development resources requires full coordination for maximum effectiveness, and

WHEREAS, Wisconsin state government recognizes its leaderwhip responsibility in the development of manpower and economic pportunity,

NOW, THEREFORE, I, PATRICK J. LUCEY, Governor of the State of Wisconsin, do hereby establish the following nonstatutory committee, the

STATE MANPOWER PLANNING COUNCIL

which will be responsible for determining the manpower needs and employment opportunities of the state and developing plans to respond a those needs and opportunities.

Members of the State Manpower Planning Council shall include: the Governor, who shall serve as Chairman; the Chairman of the Department of Industry, Labor and Human Relations, who shall serve as Vice-Chairman; the Secretaries of the Departments of Administration, Health and Social Services and Local Affairs and Development; the Superintendent of Public Instruction; the State Director of Vocational, Technical and Adult Education; the President of the University of Wisconsin and the Executive Director of the Higher Educational Aids Board:

In addition to the foregoing, there shall be appointed eight citizen members of the Council who shall be representative of manpower program clientele, business, labor, the state legislature and the general public.

The State Manpower Planning Council will meet on a quarterly **@** | basis or at the Cali of the Chairman as appropriate. The Council is specifically charged with the responsibility of: RECEIVED

1. Establishing statewide manpower objectives





 Determining organizational responsibilities and performance standards in the implementation of manpower programs;

3. Developing, on an annual basis, comprehensive state manpower plans which are based upon and responsive to the needs of the entire state. Such plans will include both recommendations for annual manpower program funding and forecosts of long-range manpower development needs and activities;

- 4. Assessing, on a regular basis, the effectiveness of the various manpower programs operating in the state and recommending changes therein as appropriate; and
- 5. Recommending to and assisting the Governor in seeking appropriate manpower legislation.

In order to facilitate fulfillment of the foregoing responsibilities, the Governor shall appoint an Executive Assistant for Manpower who will serve as Executive Secretary to the Council and who shall have assigned to him a staff of manpower planners.

To further facilitate the work of the Council, there

and a network of

AREA MANPOWER PLANNING BOARDS.

Membership on the Technical Assistance Committee shall be designated by the State Manpower Planning Council and shall consist of individuals specifically responsible for the administration of manpower programs. The Technical Assistance Committee will be chaired by the Executive Secretary of the Manpower Planning Council and shall meet monthly or upon the call of the Chairman. It will be responsible for the development and review of recommendations for Council action, the dissemination of Council guidelines and Promulgations, and the provision of technical assistance to Area Manpower Planning Boards.



XECUTINE

The network of Area Manpower Planning Boards will build upon the previously established Area CAMPS Committees and will continue to conform to Wisconsin's Uniform Administrative Districts. The Area Manpower Planning Boards will be responsible for the basic development of state manpower plans. Such plans will be based upon the area-by-area assessments of need, identification of resources, determination of priorities and requests for services. Area Boards will be responsible for on-going review of manpower activities in their areas and for appropriate reports and recommendations to the Council. In addition to supportive services received from the Council's Technical Assistance Committee, the Area Boards will receive staff support from the staff of the State Council.

DEPARTME

Until such time as appropriate elected officials within these areas have been consulted, I am asking that present Area CAMPS Committee Chairmen continue to serve in that capacity. I am further requesting that the Area Manpower Planning Boards immediately begin developing recommendations for expansion of their respective memberships to basically conform to the membership format of the State Manpower Planning Council.

In order to assure maximum effectiveness of this order, I am hereby directing the State Manpower Planning Council staff to immediately prepare procedural recommendations for the full implementation of provisions herein.
