1995 SENATE BILL 309

August 23, 1995 – Introduced by Senators Schultz, Rosenzweig, Jauch, Breske, Clausing, Rude, Panzer and Cowles, cosponsored by Representatives Freese, Musser, Hahn, Ourada, Gronemus, Baldus, Harsdorf, Zukowski, Handrick, Vrakas, Boyle, Seratti, Goetsch, Albers, Riley, Ainsworth, Urban, Grothman, Underheim, Brancel and Green, by request of Rural Wisconsin Health Cooperative.. Referred to Committee on Health, Human Services and Aging.

1 AN ACT to repeal 50.02 (6); to amend 20.435 (1) (gm); and to create subchapter

2 III of chapter 50 [precedes 50.50], 146.81 (1) (p) and 146.82 (2) (a) 17. of the

3 statutes; **relating to:** regulating rural medical centers, granting rule-making

4 authority, making an appropriation and providing penalties.

Analysis by the Legislative Reference Bureau

Under current law, the department of health and social services (DHSS) must investigate the concept of regulating a new category of health care providers known as rural medical centers.

This bill eliminates that provision and establishes rural medical centers as a category of health care providers that, beginning on July 1, 1996, must be licensed, inspected and otherwise regulated by DHSS. Under the bill, a facility may be regulated as a rural medical center if it is organized under a single governing and corporate structure, is located in a county, city, town or village that has a population of less than 15,000 and in an area that the federal bureau of the census has not defined as an urbanized area and if it provides 2 or more health care services. The health care services are those provided by a hospital, a rural primary care hospital (as defined in (the bill), a nursing home, a hospice, a rural health clinic or an ambulatory surgery center; or they are home health services, outpatient physical therapy services, end-stage renal disease services or services that are specified by DHSS by rule.

The bill establishes licensing procedures and requires that DHSS promulgate rules that establish standards for operation of rural medical centers, minimum requirements for license issuance, licensure fee amounts, and procedures and criteria for waiver of or variance from standards and requirements. As part of license issuance, DHSS must inspect the health care services provided by an applying rural medical center, except that DHSS may, instead, accept evidence that an applicant has certain current state licensure or approval, has a current medicare provider agreement, has been designated as a rural primary care hospital or satisfies requirements in DHSS rules. The bill exempts a hospital, nursing home, hospice or home health agency that provides all of its services as part of a licensed rural medical center from obtaining licensure or approval and paying license or approval fees under other state laws. These facilities are not, however, exempted from standards and other regulations for operation under those licensing laws, unless the laws conflict with laws regulating rural medical centers. The bill authorizes DHSS to conduct unannounced inspections of rural medical centers and requires a rural medical center to provide access to any patient health care records necessary to fulfill the purpose of any DHSS inspections or investigations. The bill prohibits an unlicensed entity from using the phrase "rural medical center" to describe itself, prohibits intentional interference with any investigation by DHSS of alleged violations, prohibits certain intentional retaliation or discrimination against employes or patients and prohibits intentional destruction or modification of original inspection reports.

4 (11) "Rural medical center" means an arrangement of facilities, equipment,
5 services and personnel that is all of the following:

(10) "Rural health clinic" has the meaning given under 42 USC 1395x (aa) (2).

- (a) Organized under a single governing and corporate structure.
- (b) Capable of providing or assuring health care services, including appropriate
 referral, treatment and follow-up services, at one or more locations in a county, city,
 town or village that has a population of less than 15,000 and that is in an area that
 is not an urbanized area, as defined by the federal bureau of the census.
- (c) A provider of at least 2 health care services under the arrangement or
 through a related corporate entity.
- (12) "Rural primary care hospital" means a facility that is currently designated
 by the federal health care financing administration as meeting the applicable
 requirements of 42 USC 1395i-4 (i) (2) and of 42 CFR 485, Subpart F.

(2) Promulgate rules that establish all of the following:

- (a) For the operation of licensed rural medical centers, standards that are
 designed to protect and promote the health, safety, rights and welfare of patients who
 receive health care services in rural medical centers.
- (b) Minimum requirements for issuance of a provisional license, a regular
 initial license or a license renewal to rural medical centers.

(c) Fees for rural medical center provisional licensure and regular initial 1 $\mathbf{2}$ licensure and licensure renewal. The amounts of the fees shall be based on the health 3 care services provided by the rural medical center. (d) A procedure and criteria for waiver of or variance from standards under par. 4 $\mathbf{5}$ (a) or minimum requirements under par. (b). 6 50.52 Licensing procedure and requirements. 3. Is a rural primary care hospital.

4. Satisfies qualifications that are specified by the department by rule.

 $\mathbf{5}$ (3) Each license shall bear the name of the owner of the rural medical center. the name and address of the rural medical center and the health care services that 6 7 the department authorizes the rural medical center to provide.

- 8 (4) Unless sooner revoked or suspended, a regular initial license or a license 9 renewal issued to a rural medical center is valid for 24 months from the date of 10 issuance and a provisional license issued to a rural medical center is valid for 6 11 months from the date of issuance.
- (5) Each license shall be issued only for the rural medical center and owner that 1213 are named in the license application and may not be transferred or assigned.

50.53 Inspections and investigations. (1) The department may conduct 15unannounced inspections or investigations of a rural medical center as the 16 department considers necessary.

17(2) A rural medical center that is inspected or investigated under this section shall provide the department with access to patient health care records, regardless 18 19 of the source of patient health care payment, to fulfill the purpose of any inspections 20 or investigations that the department conducts.

21**50.54 Prohibitions.** (1) An entity that is not licensed as a rural medical 22center under this subchapter may not designate itself as a "rural medical center" or 23use the phrase "rural medical center" to represent or tend to represent the entity as $\mathbf{24}$ a rural medical center or services provided by the entity as health care services 25provided by a rural medical center.

(1) FORFEITURES. (a) Any person who 15violates this subchapter or any rule promulgated under this subchapter, except s. 16 50.54 (2), may be required to forfeit not less than \$100 nor more than \$500 for each 17offense. Each day of continued violation constitutes a separate offense. (b) In determining whether a forfeiture is to be imposed and in fixing the 18 19 amount of the forfeiture to be imposed, if any, for a violation, the department shall 20 consider all of the following factors: 211. The gravity of the violation. 22 2. Good faith exercised by the licensee. 233. Any previous violations committed by the licensee. 244. The financial benefit to the rural medical center of committing or continuing 25to commit the violation.

1 (c) The department may directly assess forfeitures provided for under par. (a). 2 If the department determines that a forfeiture should be assessed for a particular 3 violation or for failure to correct it, the department shall send a notice of assessment 4 to the rural medical center. The notice shall specify the amount of the forfeiture 5 assessed, the violation, and the statute or rule alleged to have been violated, and 6 shall inform the licensee of the right to a hearing under par. (d).

(d) A rural medical center may contest an assessment of forfeiture by sending,
within 10 days after receipt of notice under par. (c), a written request for hearing
under s. 227.44 to the division of hearings and appeals under s. 15.103 (1). The
division shall commence the hearing within 30 days after receipt of the request for
hearing and shall issue a final decision within 15 days after the close of the hearing.
Proceedings before the division are governed by ch. 227.

(e) All forfeitures shall be paid to the department within 10 days after receipt
of notice of assessment or, if the forfeiture is contested under par. (d), within 10 days
after receipt of the final decision, unless the final decision is appealed and the
decision is in favor of the appellant. The department shall remit all forfeitures paid
to the state treasurer for deposit in the school fund.

18 (2) OTHER PENALTY. Whoever violates s. 50.54 (2) may be fined not more than
19 \$1,000 or imprisoned for not more than 6 months or both.

(3) INJUNCTION. The department may, upon the advice of the attorney general,
who shall represent the department in all proceedings under this subsection,
institute an action in the name of the state in the circuit court for Dane County for
injunctive relief or other process against any licensee, owner, operator,
administrator or representative of any owner of a rural medical center for the
violation of any of the provisions of this subchapter or rules promulgated under this

1 subchapter if the department determines that the violation seriously affects the care, 2 treatment, health, safety, rights, welfare or comfort of patients. 3 50.56 Applicability.
