Analysis by the Legislative Reference Bureau

This bill is a reorganization and renumbering of chapter 59 of the statutes, which deals with counties, and changes cross-references throughout the statutes to reflect the renumbering of chapter 59. The bill makes no substantive changes to current law.

The bill also conforms existing statute text to current style, including the following:

1. Removes certain archaic terms, such as “hereinafter”, “aforesaid”, “wherein” and “said”.

2. Standardizes the uses of terms such as “enact ordinances” and “adopt resolutions”.

3. Removes phrases such as “county board of supervisors” and substitutes “board”, which is the defined term in the statutes. Similar changes are made for other defined terms, such as “clerk” for “county clerk” and “municipality” for “city, village or town”.

4. Deletes redundant phrases, such as “Any and all” and “Each and every” and substitutes “All”, “every”, “a” or “an”.

15 (a) *Composition; supervisory districts.* Within 60 days after the population
16 count by block, established in the decennial federal census of population, and maps
17 showing the location and numbering of census blocks become available in printed
18 form from the federal government or are published for distribution by an agency of
19 this state, but no later than July 1 following the year of each decennial census, the
20 board shall adopt and transmit to the governing body of each city and village wholly
21 or partially contained within the county a tentative county supervisory district plan
22 to be considered by the cities and villages when dividing into wards. The plan shall
23 specify the number of supervisors to be elected and shall divide the county into a
24 number of districts equal to the number of supervisors, with each district
25 substantially equal in population and consisting of contiguous whole wards. Except

1 as otherwise provided in this paragraph, the board shall develop and adopt the

4 government or are published for distribution by an agency of this state, but no later
5 than July 1 following the year of each decennial census, each board shall propose a
6 tentative county supervisory district plan setting forth the number of supervisory
7 districts and tentative boundaries or a description of boundary requirements, hold
8 a public hearing on the proposed plan and adopt a tentative plan. The proposed plan

7 2. Any adjoining counties upon a finding by their county boards that there is
8 need therefor may jointly cause to be formed an agency which shall be the sole agency
9 and instrumentality of the counties for the purposes stated in this section subsection.

10 3. The county board may appropriate such sums of money as are necessary or
11 advisable for the benefit of the agency and prescribe the terms and conditions of such
12 appropriation.

13 4. The agency shall be a separate and distinct public instrumentality and body
14 corporate and politic exercising public powers determined to be necessary by the
15 state for the purposes set forth in sub. ~~(2)~~ par. (b). The agency shall have no power
16 at any time to pledge the credit or taxing power of the state, any county, or any
17 municipality or political subdivision, but all of its obligations shall be deemed
18 considered to be obligations solely of the agency.

20 ~~the following authority and shall be subject to the following restrictions~~ All of the
21 following apply to an agency:

22 1. Proposed articles of incorporation and proposed bylaws shall be made

1 2. The articles of incorporation shall be signed and acknowledged by persons

2 which aid and assistance may take the form of be loans either secured or unsecured,

6 of the agency to acquire by purchase, lease or otherwise any real or personal property

19 municipality through which a route of the expressway passes. If the approval of the
20 governing body is not granted within 60 days from the date of submission, the board
21 shall present the general plan to the department of transportation, which shall hold
22 a public hearing on that part of the plan which is located in such municipality. After
23 the hearing, the department of transportation shall make recommendations to the
24 board with reference to the matters objected to by the municipal governing body.
25 Thereafter the board shall incorporate the recommendations in its general plan.

1 When the approval of the necessary local governing bodies has been obtained or the
2 recommendation of the department of transportation has been obtained in lieu
3 thereof, the general plan shall be finally adopted by the board. Thereafter, the board
4 may amend the general plan as it ~~deems~~ considers proper.

5 (b) *Procedure upon adoption of plan.* The board shall adopt tentative
6 expressway project budgets for the units of the comprehensive plan adopted under
7 par. (a) and in order of construction as the board ~~deems~~ considers proper. Each
8 budget shall give reasonably detailed estimates of expenditures required to complete
9 the expressway project and shall also give an estimate of the state and federal aid
10 which will become available for the project. The board shall determine the amount
11 of the county's share of the cost of the project and the financing thereof, either from
12 the authorization of county expressway bonds under s. 67.04, or by determining the
13 amounts to be included in the budgets during the construction years, or by transfer
14 from unappropriated surplus under s. ~~59.84~~ 59.60 (5), or by any combination of the
15 foregoing. When the board determines that county funds for an expressway project
16 shall be financed in whole or in part from current budgets, the county auditor shall
17 include such amounts in the proper proposed budget under s. ~~59.84~~ 59.60 (5). The
18 county board shall adopt expressway project budgets with such changes as it ~~deems~~
19 considers proper. When adopted, the county contribution to the expressway project
20 shall constitute a legal appropriation and shall be expendable to the extent that
21 expressway bonds have been authorized or money otherwise provided. The board
22 may amend any expressway project budget and may transfer appropriations from
23 one expressway project to another.

24 (c) *Acceptance of gifts.* The board may accept, ~~in the name of the county,~~ grants,
25 conveyances and devises of land, improvements thereon and ~~any and~~ all interests

1 whatsoever therein and bequests and donations of money to be used for expressway
2 purposes.

3 (d) *Acquisition of lands and interests therein.* 1. The board may acquire in the
4 name of the county or in the name of the state when so directed by the department
5 of transportation, by donation, purchase, condemnation or otherwise, such lands,
6 including any improvements ~~thereon~~ on the lands, and any interests, easements,
7 franchises, rights and privileges in or pertaining to lands, of whatever nature and
8 by whomsoever owned, as the board ~~deems~~ considers necessary and required for
9 expressway purposes, and to dispose of the ~~same~~ such lands. The board may use
10 expressway lands for the location or relocation of any facility for mass
11 transportation, including private or public utilities. The board may purchase or
12 accept donation of remnants of tracts or parcels of land remaining at the time or after
13 it has acquired by condemnation or after or coincident with its acquisition by
14 purchase or donation portions of such tracts or parcels for expressway purposes
15 where in the judgment of the board such action would assist in rendering just
16 compensation to a landowner, a part of whose lands are required for expressway
17 purposes, and would serve to minimize the overall cost of such necessary taking by
18 the public. The county may dispose of such remnants. No lands or interest of any
19 ~~kind therein~~ in lands that are acquired as provided in this paragraph shall be
20 disposed of by the county without the consent of the board, and all ~~moneys~~ money
21 that is received for any such lands, improvements ~~thereon~~ or interests of any ~~kind~~
22 ~~therein~~ in land, so disposed of, shall be credited to the land acquisition account as an
23 abatement of expense. No lands acquired by the board, as provided in this
24 subsection, in the name of or in trust for the state, shall be disposed of by the county
25 without prior approval of the state, and the proceeds of the sale shall be remitted to

1 the state or retained and used for expressway purposes when so directed by the
2 department of transportation.

3 2. After the general plan of expressways has been adopted, the board may, for
4 specific approved highway projects or otherwise, acquire lands and interests therein
5 of the nature and in the manner specified in this paragraph for the right-of-way of
6 the expressways in advance of the time of the adoption of an expressway project
7 budget including the lands and interests. Such power may be exercised when in the
8 judgment of the board the public interest will be served and economy effected by
9 forestalling development of the lands which will entail greater acquisition costs to
10 if acquired at a later date. Upon such acquisition the board may improve, use,
11 maintain or lease the lands until the same are required for expressway construction.
12 It is recognized that there may necessarily be a period of time between the
13 acquisition of needed lands for right-of-way and the commencement of actual site
14 clearance and construction, but such fact shall not minimize the public purpose of
15 the acquisition. The owners of the lands at the time of the acquisition shall have the
16 first right to enter into lease thereof with the county until the lands are needed for
17 expressway construction. ~~Any lands~~ Lands so leased for more than one year shall
18 be subject to general property taxation during the term of the lease. All rentals shall
19 be credited to the project or to the expressway land acquisition account. The board
20 may provide out of funds acquired by bond issue or otherwise a land acquisition fund
21 not in excess of \$5,000,000 of expendable funds at any one time, to be used primarily
22 for the acquisition of lands, improvements thereon and interests therein as specified
23 in this subsection prior to the approval of the specific expressway project for which
24 the lands or interests will be required. The fund shall be adjusted to reflect
25 acquisition costs for lands and interests therein thereafter incorporated in specific

1 approved expressway projects by transferring both the appropriations and the
2 acquisition costs therefor to the proper expressway improvement expenditures
3 account.

4 3. When an expressways project for which lands, improvements thereon and
5 ~~any or~~ all interests therein have been paid for from any expressway land acquisition
6 fund or account becomes activated by the board, the department of transportation
7 may reimburse the expressway land acquisition fund by allocation of funds which
8 may be made available under any state or federal statute to reimburse prior
9 disbursements from the land acquisition fund to acquire the lands, improvements
10 thereon or interests therein or appurtenant thereto. All state or federal funds thus
11 received shall be used for expressway purposes.

12 4. The board, in acquiring lands, improvements ~~thereon~~ on lands and interests
13 ~~therein~~ in lands and appurtenant ~~thereto~~ to lands, as provided in this subsection,
14 may acquire the ~~same~~ lands in fee simple or by easement for highway purposes as
15 it may by order determine. In any such acquisition, the board may, and shall when
16 requested by the department of transportation, act in the name of the state as the
17 agent of the department of transportation and in other cases shall act in the name
18 of the county. The board in making the acquisition may proceed under ch. 32.

19 5. Whenever, ~~prior to~~ before actual expressway project construction, a saving
20 is shown to be probable in the cost of constructing a proposed new municipal or
21 privately owned public utility (which, if presently installed in a public way in a
22 proposed normal manner, would ultimately be interfered with by expressway
23 construction) by initially constructing the municipal or privately owned public
24 utility in other than a normal manner to accommodate future expressway
25 construction, in order to effect savings by avoiding reconstruction and relocating at

1 a later date, the board may contract with the municipal government or utility
2 company involved for the construction of the public utility in such other than normal
3 manner and to pay to it the portion of the cost of the special construction in excess
4 of the cost if constructed in the proposed normal manner. Funds for such purpose
5 may be taken from the land acquisition fund authorized in subd. 2.

6 6. When the board has acquired title to lands in fee either for the county or the
7 state, the county or a person authorized by the county may use and develop any
8 portion of the lands not directly needed for expressway-roadway purposes and which
9 do not interfere with the primary expressway purpose, and without ~~exclusion~~
10 limitation because of enumeration ~~the power to~~ may use the subsoil beneath the
11 ground, the ground level area or air space above the ground, for parking, storage or
12 building purposes subject to municipal land use zoning regulations except as to
13 parking, but if the expressway right-of-way area is either on the federal interstate
14 system or on a state trunk highway, the county shall obtain the consent of the
15 department of transportation to the development and use prior to construction or
16 initiation of that use. The state shall receive a share of the rentals or sale price
17 derived from the use in the proportion that the amount of federal or state funds used
18 in the purchase of the site bears to the total cost of the land and improvement which
19 is the subject of the sale or rental. Such sharing shall not be made until the county
20 or the person authorized by the county has been reimbursed for all sums expended
21 by it, in the developments referred to in this paragraph, and such sharing shall
22 terminate when the fair proportion of the federal and state funds allocable to the
23 purchase of the area so developed has been reimbursed. In lieu of sharing in the
24 proportion of the amount of federal or state funds used in the purchase of the site to
25 the total cost of the land and improvement which is the subject of the sale or rental,

1 the state and the county or the person authorized by the county may share the rentals
2 or sale price on the basis of a different formula for such sharing if the department
3 of transportation and the county agree to a different formula.

4 7. Before the county authorizes any person to use or develop lands under subd.
5 6., the county shall make a reasonable effort to determine whether any institution
6 of higher education in the vicinity of the lands has demonstrated to the county an
7 interest in the use or development of the lands. The county shall give preference to
8 proposals for the use or development of lands under subd. 6. which are submitted by
9 a an institution of higher education in the vicinity of those lands and which provide
10 for reasonable payment to the county under a lease of or other authority to use or
11 develop those lands.

12 (e) *Contracts.* The board may construct and administer projects under its
13 jurisdiction, and may contract in the name of the county with the department of
14 transportation as may be necessary under state and federal statutes to secure state
15 and federal aid on expressway projects.

16 (f) *Vacation, relocation, reconstruction of streets, alleys, etc.* 1. Whenever the
17 board determines that it is necessary for the proper construction of an expressway
18 project that streets or alleys be vacated in whole or in part, or be dead-ended at the
19 expressway right-of-way line; that existing streets or alleys be relocated; that new
20 streets or alleys be laid out and opened; that accessory streets or ramps to serve as
21 approaches to the expressway be constructed; that existing streets leading to or off
22 from expressway ramps be designated as one-way streets for such reasonable
23 distance as is necessary for the proper operation of the facility; that the grade of
24 existing streets be changed or that the traveled portion of existing streets be widened
25 and improved so as to facilitate entrance to the expressway, it shall formulate a

1 tentative order evidencing such requirement and file a certified copy thereof with the
2 municipal clerk of each ~~town, city or village~~ municipality affected by the tentative
3 order for consideration thereof by the governing body of the ~~town, city or village~~
4 municipality.

5 2. The governing body or the committee which the governing body designates
6 shall hold a public hearing ~~in considering~~ to consider the tentative order and shall
7 publish in the county a class 2 notice, under ch. 985, of such ~~the~~ hearing.

8 3. If the tentative order is not approved within 90 days from the date of the
9 filing, the board shall present the tentative order to the department of
10 transportation, which shall hold a public hearing ~~thereon~~ on the order, of which
11 hearing the municipality in question shall be given notice. The department of
12 transportation shall have jurisdiction to pass upon the necessity and reasonableness
13 of the proposed tentative order, and it may approve, modify and approve or
14 disapprove the order. The department's decision ~~thereon~~ shall be final, with no
15 review allowed under ch. 227.

16 4. If the tentative order is approved by the governing body of the municipality
17 affected, or if it is approved or modified and approved by the department of
18 transportation, the board may thereafter issue a final order identical with the
19 original tentative order as modified by the department's decision. A certified copy
20 of the final order shall be filed with the municipal clerk of the ~~town, village or city~~
21 municipality affected. Notice of the making of the order shall be published in the
22 county as a class 1 notice, under ch. 985.

23 5. The governing body of the ~~town, village or city~~ municipality shall, within 30
24 days after filing, take the necessary action to comply with the order and in so doing
25 shall not be limited by the objections of any an abutting owner, and s. 80.32 (4) shall

1 not be applicable to any vacation or discontinuance required by the order, and any
2 such ~~town, village or city~~ municipality may act upon the initiative of its governing
3 body without the necessity of obtaining the consent of ~~any~~ an abutting ~~owners~~ owner,
4 notwithstanding chs. 60, 61, 62 and 66 and s. 80.32 (4) and any other provisions of
5 law to the contrary.

6 6. If the ~~town, village or city~~ municipality does not comply with the order within
7 a reasonable time, the board may perform the work required by the order with its
8 own forces or by contract and in so doing and for such purpose shall have the same
9 powers and freedom from limitations as are vested by chs. 60, 61, 62 and 66 and this
10 subsection in the governing body of the ~~town, village or city~~ municipality.

11 7. The plans, specifications, proposed contracts and the appraisal of damages,
12 if any, caused to abutting owners by compliance with the order shall be subject to
13 approval by the board ~~prior to~~ before the commencement of any work under the order
14 but ~~such~~ the requirement for approval of the order shall not affect the abutting
15 property owners' rights of appeal from the determination of damages by the
16 commissioner of public works of the city or by any other authorized person or body.

17 8. The cost of performing such work as may be required by any order of the
18 board under this subsection, including damages granted for changes of legally
19 established grade or necessary acquisition of lands, shall be paid by the county from
20 expressway funds as an item of the particular expressway project budget upon
21 presentation of vouchers which have been approved for payment by the governing
22 body of the ~~town, village or city~~ municipality and the board. If the payment made
23 by the county has been increased by reason of the ~~town, city or village~~ municipality
24 requesting an expenditure in excess of replacement or termination costs, the ~~town,~~
25 ~~village or city~~ municipality shall reimburse the county for the excess cost. The

1 reimbursement shall be credited by the county to abatement of the respective
2 expense for which it was received.

3 (g) *Relocation of municipal utilities.* 1. The board, subject to approval by the
4 public service commission after public hearing to all interested parties in cases in
5 which the public service commission would have jurisdiction, may by order require
6 any ~~town, village or city~~ municipality through which an expressway project is to be
7 constructed to remove, relocate and replace in kind or with equal facilities, or if the
8 ~~town, village or city~~ municipality shall so request by enlarged facilities, any sewer,
9 street lighting or other like utility service the location of which interferes with
10 construction of an expressway project. If enlarged facilities are requested the ~~town,~~
11 ~~village or city~~ municipality shall bear that part of the cost of the improvement which
12 exceeds the cost of the replacement of the existing facility in kind or with equal
13 materials or facilities. However the board shall bear the excess cost where the
14 installation of the enlarged facility is caused by designed construction and use of the
15 expressway. A certified copy of the order shall be filed with the municipal clerk of
16 each ~~town, village or city~~ municipality affected and upon the filing each such ~~town,~~
17 ~~village or city~~ municipality shall within 30 days take the necessary action to comply
18 with the order. All plans, specifications and contracts for any of the work shall be
19 subject to approval by the board. When the work under specific contracts has been
20 completed and approved by the governing body of the ~~town, village or city~~
21 municipality and the board, the county shall pay for the work from expressway funds
22 as an item of the particular expressway project budget. If the payments made by the
23 county exceed the replacement costs and the additional cost was incurred at the
24 specific request of the ~~town, village or city~~ municipality, the ~~town, village or city~~
25 municipality shall reimburse the county therefor. The reimbursement shall be

1 credited by the county as an abatement of the respective expenses for which it the
2 reimbursement is received. If ~~deemed~~ considered feasible and desirable by the board
3 any work provided for in this paragraph may be performed by the board or directly
4 by contract. In such cases the ~~town, village or city~~ municipality in which the work
5 is performed shall cooperate with the board.

6 2. With respect to any water utility of any ~~city, town or village~~ municipality
7 which utility, in addition to providing water for human consumption, performs
8 governmental functions in the way of providing water for fire protection, sewerage
9 operation, street sanitation, park bathing pools and the like, the board shall have the
10 same powers and be subject to the same obligations as are provided in subd. 1.
11 However, water storage tanks, water pumping stations and water reservoirs may be
12 removed, relocated and replaced by the board only with the consent and approval of
13 the ~~city, town or village~~ municipality owning and operating the facilities.

14 (h) *Private occupancy of streets; relocation.* 1. All persons other than those
15 mentioned in par. (g) lawfully having buildings, structures, works, conduits, mains,
16 pipes, wires, poles, tracks or any other physical facilities in, over or under the public
17 lands, streets, highways, alleys, parks or parkways of the county, or of any ~~town,~~
18 ~~village or city~~ municipality therein, which in the opinion of the board in any manner
19 interfere with the construction of ~~any~~ an expressway project or the relocation or
20 maintenance ~~thereof~~ of such a project, shall upon order by the board promptly so
21 accommodate, relocate or remove the ~~same as may be ordered by the board so as to~~
22 ~~remove such interference~~ interfering physical facilities.

23 2. Whenever the board proposes to consider adoption of an expressway project,
24 it shall give notice ~~thereof~~ of the proposal to each privately owned public utility or
25 other person affected by the project indicating in the notice the action which it desires

1 the utility or person to take, and the utility or person shall within 90 days after
2 receipt of the notice furnish to the board its plan to comply with the request.

3 3. When the utility, ~~pursuant to~~ under the board's order, proceeds with the work
4 in a manner satisfactory to the board, the county shall pay the utility from
5 expressways funds upon monthly estimates of work performed and submitted for
6 payment by the utility, two-thirds of the net cost incurred by the utility in performing
7 the work, after deducting reasonable and fair credits for items salvaged, for any
8 betterments made at the option of the company and for the value as carried on the
9 utility's books, of the used life of a facility retired from use if the service life of the new
10 facility will extend beyond the expectancy of the one removed. The county shall not
11 be liable to pay any value ~~whatever~~ for utility facilities where use of the ~~same~~
12 facilities has been abandoned for reasons other than the construction or proposed
13 construction of an expressway project even though the installation is intact.

14 4. The board and any utility that is required to accommodate, relocate or
15 remove a utility facility described in subd. 1. may by agreement provide for the
16 respective amounts of the cost to be borne by each so as to resolve ~~any a~~ a dispute as
17 to the allowance of charges and credits as set forth in this paragraph. When the
18 agreement has been concluded, the county shall pay out of expressway funds its
19 share of the cost upon monthly estimates of work performed and submitted for
20 payment by the utility.

21 5. If the board and any privately owned public utility are unable to agree as to
22 the division of the costs, either may appeal to the public service commission, which
23 ~~body~~ shall determine the proper amounts of reimbursement according to the
24 provisions expressed in this paragraph. Either party may ~~have a~~ petition the circuit
25 court for review of the public service commission's decision in the manner provided

1 in ~~ch. 227 s. 227.53~~. If it is determined upon such review that the county has paid
2 more than two-thirds of the net cost of compliance by a utility with the board's order,
3 any overage shall be reimbursed to the county by the utility.

4 6. No appeal shall delay the construction of the expressway project or
5 compliance by the privately owned public utilities with the orders of the board.
6 Compliance shall not prejudice the rights of either the board or the utilities in any
7 pending appeal.

8 7. If ~~any a~~ person refuses to comply with an order of the board as promulgated
9 under this paragraph, the board may ~~have a writ of assistance from~~ apply to the
10 circuit court for a writ of assistance to compel compliance, and the person shall be
11 liable for all damages caused to the board by the delay.

12 8. If a railroad track ~~crosses or is crossed by~~ and an expressway project cross,
13 ss. 195.28 to 195.29 shall apply.

14 9. The reimbursement ~~to~~ of private utilities ~~provided in~~ under this paragraph
15 shall be limited to expressway projects as provided in this section.

16 (i) *Entry on private lands.* The board, its agents or servants, may enter ~~upon~~
17 any land in the county for the purpose of making surveys, test borings or any other
18 type of examination necessary in the performance of its duties and shall be liable to
19 restore the surface of ~~said~~ the lands to the same or as good condition as existed at the
20 time of ~~such~~ the entry and for any other actual and demonstrable damage caused to
21 ~~said~~ the lands by ~~such~~ the entry.

22 (j) *Traffic types and speed limits.* After an expressway project has been certified
23 as completed, the public body having jurisdiction over the maintenance thereof shall
24 have the power to regulate the type of vehicular use of such portion of the expressway
25 except as limited by federal and state laws and regulations, and the power to fix

1 speed limits thereon not in excess of the maximum speed limits for state trunk
2 highways, and to provide and enforce reasonable penalties for infraction of such
3 vehicular use regulation or speed limits. Notwithstanding s. 346.16 (2), the use of
4 the expressways by pedestrians, mopeds, motor bicycles, motor scooters, bicycles,
5 funeral processions, animals on foot and the hauling of oversized equipment without
6 special permit shall be prohibited when an ordinance in conformity herewith is
7 adopted with this section is enacted by the county board, but any a forfeiture
8 provided therein shall not exceed the maximum forfeiture under s. 346.17 (2). The
9 county board may not prohibit the towing of disabled vehicles on expressways, except
10 that the board may prohibit the towing of disabled vehicles during the peak hours
11 of 7 a.m. to 9 a.m. and 4 p.m. to 6:30 p.m. as established under county ordinance and
12 except that the board may establish procedures for and may contract for the towing
13 of vehicles which have become disabled on the expressway.

14 (k) *Building permits on lands in expressway routes.* Each ~~town, village or city~~
15 municipality through which a route of the approved expressway plan, as amended
16 from time to time, shall pass, shall be given a formal notice of the route and a map
17 thereof. Thereafter, when an owner of land within the right-of-way of an
18 expressway indicated on the map applies for a building permit affecting such lands,
19 final action on the application shall be deferred for a reasonable time not exceeding
20 60 days and the municipality shall within 5 days after receipt of the application
21 notify the board thereof.

22 (L) *Forces to construct expressway projects.* The board may use its own ~~forces~~
23 employees to construct expressway projects in whole or in part ~~or may use county~~
24 highway forces for such purposes.

1 (m) *Rules and regulations.* The board shall have power to make all rules and
2 regulations concerning its work.

3 (n) *Meetings; reports.* The board shall hold meetings for the transaction of
4 business under this section and all such meetings shall be open to the public. The
5 board shall prepare annually a report of its official transactions and expenditures
6 under this section and shall mail the statement to the governor, to the mayor of the
7 largest city in the county and to the chief executive head officer of the governing
8 boards bodies of all ~~cities, towns and villages~~ municipalities in the county.

9 (o) *Applicability of pars. (a) to (n).* Paragraphs (a) to (n) also apply ~~insofar, as~~
10 far as applicable, to the exercise of the powers and duties of the board in the planning
11 and construction of mass transit facilities.

12 (4) TRANSFER OF PRIOR EXPRESSWAY STUDIES AND REPORTS. The county expressway
13 and transportation commission that is created under s. 59.965 (2), 1977 stats., and
14 the governmental authorities of the largest city in the county shall transfer and
15 deliver to the board the original or certified copy of all maps and engineering studies
16 and reports pertaining to an expressways system in the city and county, together
17 with all contracts pertaining to the creation and construction of expressways. Upon
18 demand by the board the largest city in the county with the approval of the common
19 council shall execute and deliver to the county quitclaim deeds of all lands acquired
20 ~~or,~~ dedicated or owned by the city and needed for the purpose of right-of-way for the
21 expressways, if the cost thereof of the lands was included in the determination of
22 prior expressway expenditures.

23 (6) REIMBURSEMENT FOR PRIOR EXPRESSWAY FINANCING. Municipalities shall be
24 reimbursed for prior expressway project expenditures. ~~Any expressway~~ Expressway
25 projects under construction at the time the county expressway and transportation

1 commission was created and the transfer of functions to the commission was
2 effectuated under s. 59.965, 1977 stats., shall be completed by the board. Such
3 municipalities shall be reimbursed for prior expressway expenditures and ~~obligation~~
4 obligations incurred for the cost of right-of-way acquisition and clearance,
5 construction engineering, and actual construction to the extent of the municipalities'
6 contribution from tax levy or bond funds. Each such municipality shall calculate its
7 contribution and certify the contribution with full data to the board. It shall then be
8 subject to consideration, audit and approval by the board. If approved by the board,
9 reimbursement shall be made on a 10-year instalment basis by levying a tax against
10 all the municipalities of the county on an equalized valuation basis, and offsetting
11 the amount thereof to the municipalities entitled to reimbursement.

12 (7) AGREEMENTS FOR USE OF FEDERAL AID TO RETIRE MATURITIES. The department
13 of transportation and ~~any county having a population of 500,000 or more~~ the board
14 may enter into an agreement providing that when the proceeds of bonds issued by
15 the county are expended in the improvement of a portion of the federal aid highway
16 system as a part of the comprehensive expressway system in the county, and are so
17 expended under ch. 84, and in compliance with section 5 of the federal aid highway
18 act of 1950, or acts amendatory of or supplementary to such section, and regulations
19 applicable thereto, the sum of money derived from federal aid for highways which
20 may be authorized by the congress and apportioned to this state for any fiscal year
21 as shall be stipulated in the agreement may be applied to aid in retirement of annual
22 maturities of the principal indebtedness of such bonds, and that to the extent that
23 federal aid can be claimed and received by the state for such purpose, it will upon
24 receipt be paid to the county. Any money so paid shall be deposited by the county in

1 the sinking fund provided for the retirement of the bond issue of which the bonds
2 formed a part.

16 (b) 1. Comprehensive surveys, studies and analyses of the history, existing land
17 use, population and population density, economy, soil characteristics, forest cover,
18 wetland and floodplain conditions and other human and natural features of the
19 county and shall include the master plan, if any, of any city or village, which was
20 adopted ~~pursuant to~~ under s. 62.23 (2) or (3) and the official map, if any, of such city
21 or village which was adopted ~~pursuant to~~ under s. 62.23 (6) in such county, without
22 change.

23 2. Based on ~~sueh~~ the comprehensive surveys, studies and analyses, the plan
24 may identify goals and objectives for the future physical development of the county
25 with respect to: public and private use of land and other natural resources; highways

1 including bridges, viaducts, parkways and other public ways; parks, playgrounds,
2 hunting and fishing grounds, forests and other facilities of a recreational nature;
3 public buildings and institutions including schools; sanitary and storm sewers,
4 drainage and measures for disposal of refuse and waste; reducing and preventing
5 stream and lake pollution; flood control; public and private utilities including water,
6 light, heat, transportation, pipelines and other services; industrial and commercial
7 sites; historic districts; and other factors which will improve the physical and
8 economic situation of the county.

9 (c) The development plan may be in the form of descriptive material, reports,
10 charts, diagrams or maps. Each element of the development plan shall describe its
11 relationship to other elements of the plan and to statements of goals, objectives,
12 principles, policies or standards.

13 (d) The county zoning agency shall hold a public hearing on the development
14 plan before approving it. After approval of the plan the county zoning agency shall
15 submit the plan to the county board for its approval and adoption. The plan shall be
16 adopted by resolution and when adopted it shall be certified as provided in sub. (2)
17 (f). The development plan shall serve as a guide for public and private actions and
18 decisions to assure the development of public and private property in appropriate
19 relationships.

20 (e) A master plan adopted under s. 62.23 (2) and (3) and an official map that
21 is established under s. 62.23 (6) shall control in unincorporated territory in a county
22 affected thereby, whether or not such action occurs ~~prior to~~ before the adoption of a
23 development plan.

24 **(4) EXTENT OF POWER.** (intro.) For the purpose of promoting the public health,
25 safety and the general welfare the county board of ~~any county~~ may by ordinance

1 effective within the areas within such county outside the limits of incorporated
2 villages and cities establish districts of such number, shape and area, and adopt such
3 regulations for each such district as the county board ~~shall deem~~ considers best
4 suited to carry out the purposes of this section. The powers granted by this section
5 shall be exercised through an ordinance which may, subject to sub. (4e), determine,
6 establish, regulate and restrict:

7 (c) The areas in and along, or in or along, natural watercourses, channels,
8 streams and creeks in which trades or industries, filling or dumping, erection of
9 structures and the location of buildings may be prohibited or restricted.

10 (f) The location of buildings and structures that are designed for specific uses
11 and designation of uses for which buildings and structures may not be used or
12 altered.

13 (k) The percentage of a lot which may be occupied, size of yards, courts and
14 other open spaces.

15 **(4c)** CONSTRUCTION SITE ORDINANCE LIMITS. Except as provided in s. 101.1205
16 (5m), an ordinance that is enacted under sub. (4) may only include provisions that
17 are related to construction site erosion control if those provisions are limited to sites
18 where the construction activities do not include the construction of a building.

19 **(4d)** ANTENNA FACILITIES. The board may not enact an ordinance or adopt a
20 resolution on or after May 6, 1994, or continue to enforce an ordinance or resolution
21 on or after May 6, 1994, that affects satellite antennas with a diameter of 2 feet or
22 less unless one of the following applies:

23 (a) The ordinance or resolution has a reasonable and clearly defined aesthetic
24 or public health or safety objective.

1 (b) The ordinance or resolution does not impose an unreasonable limitation on,
2 or prevent, the reception of satellite-delivered signals by a satellite antenna with a
3 diameter of 2 feet or less.

4 (c) The ordinance or resolution does not impose costs on a user of a satellite
5 antenna with a diameter of 2 feet or less that exceed 10% of the purchase price and
6 installation fee of the antenna and associated equipment.

7 **(4e) MIGRANT LABOR CAMPS.** The board may not enact an ordinance or adopt a
8 resolution that interferes with any repair or expansion of migrant labor camps, as
9 defined in s. 103.90 (3), that are in existence on May 12, 1992, if the repair or
10 expansion is required by an administrative rule that is promulgated by the
11 department of industry, labor and job development under ss. 103.90 to 103.97. An
12 ordinance or resolution of the county that is in effect on May 12, 1992, and that
13 interferes with any repair or expansion of existing migrant labor camps that is
14 required by such an administrative rule is void.

15 **(4g) AIRPORT AREAS.** In any a county which has created a county zoning agency
16 under sub. (2) (a), the county's development plan shall include the location of any part
17 of an airport, as defined in s. 62.23 (6) (am) 1. a., that is located in the county and of
18 any part of an airport affected area, as defined in s. 62.23 (6) (am) 1. b., that is located
19 in the county.

20 **(4m) HISTORIC PRESERVATION.** ~~Any~~ A county, as an exercise of its zoning and
21 police powers for the purpose of promoting the health, safety and general welfare of
22 the community and of the state, may regulate by ordinance any place, structure or
23 object with a special character, historic interest, aesthetic interest or other
24 significant value, for the purpose of preserving the place, structure or object and its
25 significant characteristics. The county may create a landmarks commission to

1 designate historic landmarks and establish historic districts. The county may
2 regulate all historic landmarks and all property within each historic district to
3 preserve the historic landmarks and property within the district and the character
4 of the district.

5 (5) FORMATION OF ZONING ORDINANCE; PROCEDURE. (a) When the county zoning
6 agency has completed a draft of a proposed zoning ordinance, it shall hold a public
7 hearing thereon, following publication in the county of a class 2 notice, under ch. 985.
8 After such hearing the agency may make such revisions in the draft as it ~~shall deem~~
9 considers necessary, or it may submit the draft without revision to the ~~county~~ board
10 with recommendations for adoption. Proof of publication of the notice of the public
11 hearing held by such agency shall be attached to its report to the ~~county~~ board.

12 (b) When the draft of such ~~the~~ ordinance, recommended for ~~adoption~~ enactment
13 by the zoning agency, is received by the ~~county~~ board, it may ~~adopt~~ enact the
14 ordinance as submitted, or reject it, or return it to the agency with such
15 recommendations as the ~~county~~ board may see fit to make. In the event of such
16 return subsequent procedure by the agency shall be as if the agency were acting
17 under the original directions. When ~~adopted~~ enacted, duplicate copies of the
18 ordinance shall be submitted by the ~~county~~ clerk by registered mail to each town
19 clerk for consideration by the town board.

20 (c) A county ordinance enacted as ~~provided by~~ under this section shall not be
21 effective in any town until it has been approved by the town board. If the town board

6 (d) The ~~county~~ board may by a single ordinance repeal an existing county
7 zoning ordinance and reenact a comprehensive revision thereto in accordance with
8 this section. "Comprehensive revision" ~~as used herein, in this paragraph,~~ means a
9 complete rewriting of an existing zoning ordinance which changes numerous zoning
10 provisions and alters or adds zoning districts. The comprehensive revision may
11 provide that the existing ordinance shall remain in effect in a town for a period of up
12 to one year or until the comprehensive revision is approved by the town board,
13 whichever period is shorter. If the town board fails to approve the comprehensive
14 revision within a year neither the existing ordinance nor the comprehensive revision
15 shall be in force in that town. Any repeal and reenactment prior to November 12,

2 abutting owners of over 50% of the total perimeter of the area proposed to be altered

4 ~~such~~ the ordinance may be deferred until the zoning agency has had a reasonable

18 section and not in conflict therewith. Such procedures may, but are not required to,
19 provide for public hearings before the county board. The public hearing provided by
20 sub. (5) (a) and (e) 2. is deemed to be sufficient for the requirements of due process
21 whether or not the county board holds a further public hearing thereafter.

22 (7) CONTINUED EFFECT OF ORDINANCE. Whenever ~~any~~ an area which has been
23 subject to a county zoning ordinance petitions to become part of a city or village ~~or~~
24 city, the regulations imposed by ~~such~~ the county zoning ordinance shall continue in
25 effect, without change, and shall be enforced by ~~such~~ the city or village ~~or city~~ until

23 **(10) NONCONFORMING USES.** (a) An ordinance enacted under this section shall
24 may not prohibit the continuance of the lawful use of any building or premises for
25 any trade or industry for which such building or premises is used at the time such

1 that the ordinances take effect, but the alteration of, or addition to, or repair in excess
2 of 50% of its assessed value of any existing building or structure for the purpose of
3 carrying on any prohibited trade or new industry within the district where such
4 buildings or structures are located, may be prohibited. The continuance of the
5 nonconforming use of a temporary structure may be prohibited. If such the
6 nonconforming use is discontinued for a period of 12 months, any future use of the
7 building and premises shall conform to the ordinance.

8 (b) 1. Except as provided under subd. 2., the ~~county~~ board shall designate an
9 officer to administer the zoning ordinance, who may be the secretary of the zoning
10 agency, a building inspector appointed under s. ~~59.07 (16)~~ 59.698 or other
11 appropriate person.

12 2. Notwithstanding subd. 1. and s. ~~59.07 (16)~~ 59.698, in any a county with a
13 county zoning agency and a county executive or county administrator, the county
14 executive or county administrator shall appoint and supervise the head of the county
15 zoning agency and the county building inspector, in separate or combined positions.
16 The appointment is subject to confirmation by the ~~county~~ board unless the ~~county~~
17 board, by ordinance, elects to waive confirmation or unless the appointment is made

17 (d) Paragraphs (b) and (c) shall not apply to ~~these~~ counties issuing building

20 **(11) PROCEDURE FOR ENFORCEMENT OF COUNTY ZONING ORDINANCE.** The ~~county~~

23 the enforcement of ~~the provisions of~~ this section, and all ordinances enacted in

25 building lines and regulations authorized by this section, shall be prescribed by

2 health, safety and the general welfare. ~~Such~~ The ordinances shall be enforced by
3 appropriate ~~fin~~ ~~es and penalties~~ forfeitures. Compliance with such ordinances may
4 also be enforced by injunctional order at the suit of ~~such~~ the county or ~~the~~ an owner
5 ~~or owners~~ of real estate within the district affected by ~~such~~ the regulation.

6 (12) PRIOR ORDINANCES EFFECTIVE. Nothing in this section shall invalidate any
7 county zoning ordinance ~~adopted pursuant to~~ enacted under statutes in effect ~~prior~~
8 ~~to~~ before July 20, 1951.

9 (13) CONSTRUCTION OF SECTION. The powers ~~herein~~ granted in this section shall
10 be liberally construed in favor of the county exercising them, and this section shall
11 not be construed to limit or repeal any powers now possessed by ~~any such~~ a county.

12 (14) LIMITATION OF ACTIONS. A landowner, occupant or other person who is
13 affected by a county zoning ordinance or amendment, who claims that the ordinance
14 or amendment is invalid because procedures prescribed by the statutes or the
15 ordinance were not followed, shall commence an action within the time provided by
16 s. 893.73 (1), except this subsection and s. 893.73 (1) do not apply unless there has
17 been at least one publication of a notice of a zoning hearing in a local newspaper of
18 general circulation and unless there has been held a public hearing on the ordinance
19 or amendment at the time and place specified in the notice.

20 (15) COMMUNITY AND OTHER LIVING ARRANGEMENTS. For purposes of this section,
21 the location of a community living arrangement, as defined in s. 46.03 (22), a foster
22 home, as defined in s. 48.02 (6), a treatment foster home, as defined in s. 48.02 (17q),
23 or an adult family home, as defined in s. 50.01 (1), in any ~~city, village or town~~
24 municipality, shall be subject to the following criteria:
