Analysis by the Legislative Reference Bureau

Under current law, the governor, on behalf of the state, is authorized to negotiate and enter into Indian gaming compacts. These compacts are regulated by the federal Indian Gaming Regulatory Act. This bill provides that, before entering into any Indian gaming compact that has been negotiated, the governor is required to submit the proposed compact to the senate for approval. The governor may not enter into any compact until the senate, by a majority vote of those members present and voting, has approved the proposed compact in its entirety.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:
