1 AN ACT to amend 121.15 (1) (intro.); and to create 121.08 (4) and 121.15 (1m)

of the statutes; **relating to:** the school aid distribution schedule.

Analysis by the Legislative Reference Bureau

Under current law, each school district receives 15% of its total aid entitlement in September, 25% in December, 25% in March and 35% in June.

This bill allows a school district the option of receiving its aid entitlement in 10 payments from September to June. If it chooses this option, its total aid entitlement is reduced by the earnings that the school district's aid entitlement would have accrued had its aid been distributed according to the regular distribution schedule.

4	SECTION 2. 121.15 (1) (intro.) of the statutes is amended to read:
5	121.15 (1) (intro.) State Except as provided under sub. (1m), state aid under
6	s. 121.08 shall be paid to school districts according to the following distribution

8	SECTION 3. 121.15 (1m) of the statutes is created to read:
9	121.15 (1m) (a) If a school board submits a written request to the department
10	before July 1, in the following school year the department shall pay to that school
11	district an amount equal to 10% of the school district's total aid entitlement under
12	s. 121.08 in each month from September to June.
13	(b) For the September and October payments, the total aid entitlement shall
14	be estimated based upon the total aid payment in the previous year.
15	(c) For the payments from November to June, the total aid entitlement shall
16	be computed on the basis of the budget and membership report under s. 121.05.
17	(d) Payments under this subsection shall be made on the 3rd Monday of the
18	month, except that payment shall be made on the first Monday of the month for the
19	December payment and on the 4th Monday of the month for the March payment.
