Potter, Seratti, Notestein and Boyle, cosponsored by Senators Rosenzweig, Burke, Moen, Wirch, Clausing and Panzer. Referred to Committee on Finance.

AN ACT *to create* 16.40 (21) and 20.505 (1) (cm) of the statutes; **relating to:** the summer externship program for students enrolled in the University of Wisconsin Medical School and the Medical College of Wisconsin and making an appropriation.

Analysis by the Legislative Reference Bureau

The Wisconsin Institute of Family Medicine currently operates a summer externship program for students who have completed their first year at the University of Wisconsin (UW) Medical School or the Medical College of Wisconsin. Each student in the program spends 8 weeks working with a family physician.

Beginning in the 1998–99 academic year, this bill directs the department of administration annually to pay to the institute an amount equal to the amount raised by the institute for the program from other sources in the previous fiscal year, not exceeding \$100,000, for the purpose of increasing the number of students enrolled in the UW Medical School and Medical College of Wisconsin who are able to participate in the program. The bill appropriates a sum sufficient for that purpose.

SECTION 1. 16.40 (21) of the statutes is created to read:

16.40 (21) Wisconsin Institute of Family Medicine. From the appropriation under s. 20.505 (1) (cm), annually pay to the Wisconsin Institute of Family Medicine an amount equal to the amount raised by the institute for the summer externship program from other sources in the previous fiscal year, not to exceed \$100,000. The funds paid to the institute under this subsection may be used only for the purpose of increasing the number of students enrolled in the University of Wisconsin Medical School and the Medical College of Wisconsin who are able to participate in the program. If there is a sufficient number of applicants for the program from each school, the number of participants funded under this subsection from each school shall be the same. Annually by August 1, the institute shall submit to the department a report indicating the amount raised by the institute for the summer externship program from other sources in the previous fiscal year.

Section 2. 20.505 (1) (cm) of the statutes is created to read:

20.505 (1) (cm) Wisconsin Institute of Family Medicine. A sum sufficient, not to exceed \$100,000, to make the payment to the Wisconsin Institute of Family Medicine under s. 16.40 (21) for the institute's summer externship program.

SECTION 3. Effective date.

1 This act takes effect on August 1, 1998.
