Referred to Committee on Utility Regulation.
- 1 AN ACT to renumber and amend 15.79; and to amend 230.08 (2) (m) 3. of the

2 statutes; **relating to:** prohibitions regarding members of public service

3 commission.

Analysis by the Legislative Reference Bureau

Under current law, the members of the public service commission (PSC) may not have a financial interest in a railroad or public utility or serve on a committee of a political party.

This bill also prohibits members of the PSC from doing any of the following:

1. Acting as an officer or manager for a candidate, political party or committee organized to promote the candidacy of a person for public office.

- 2. Being a candidate for public office in any election.
- 3. Soliciting or receiving a contribution or service for any political purpose.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

4 SECTION 1. 15.79 of the statutes is renumbered 15.79 (1) (intro.) and amended

- 6 15.79 (1) (intro.) There is created a public service commission. No member of
- 7 the commission may have <u>do any of the following:</u>
- 8 (a) <u>Have</u> a financial interest in a railroad or public utility. If any member
- 9 voluntarily becomes so interested, the member's office shall become vacant. If the

1	member involuntarily becomes so interested, the member's office shall become
2	vacant unless the member divests himself or herself of the interest within a
3	reasonable time. No commissioner may serve
4	(b) Serve on or under any committee of a political party or act as an officer or
5	manager for any candidate, political party or committee organized to promote the
6	candidacy of any person for any public office.
7	(c) Be a candidate for public office in any election.
8	(d) Solicit or receive or be in any manner concerned with soliciting or receiving
9	any contribution or service for any political purpose.
10	(2) Each commissioner <u>of the public service commission</u> shall hold office until
11	a successor is appointed and qualified.
12	SECTION 2. 230.08 (2) (m) 3. of the statutes is amended to read:
13	230.08 (2) (m) 3. Public service commission, created under s. 15.79 (1) .
14	SECTION 3. Effective date.
