

## **1997 SENATE BILL 487**

March 4, 1998 – Introduced by LAW REVISION COMMITTEE. Referred to Committee on Economic Development, Housing and Government Operations.

AN ACT to amend 35.82 (2), 35.83 (3) (g), 35.84 (figure) line 17. (title), 35.84 (figure) line 41. (title), 35.84 (figure) line 53. (title), 35.84 (figure) line 54. (title), 35.84 (figure) column E line 54, 35.84 (figure) column H line 54, 35.84 (figure) column F line 61, 35.84 (figure) column G line 61 and 35.84 (figure) column N line 61; and to create 35.84 (figure) line 58 and 35.84 (figure) line 59 of the statutes; relating to: distribution of certain state documents (suggested as remedial legislation by the department of public instruction).

### Analysis by the Legislative Reference Bureau

This bill changes the laws governing distribution of state documents (publications). The changes include:

1. Currently, there are 2 state document depository libraries outside this state — the Library of Congress and the Center for Research Libraries, Chicago, Illinois. The bill discontinues the center as a depository and replaces it with the Council of State Governments, Lexington, Kentucky.

2. The bill provides for each selective state depository library (one that receives only selected state publications) to receive one free copy of the Blue Book and the biennial reports of state agencies.

3. The bill provides for the reference and loan library of the department of public instruction to receive one free copy of each major state publication. Currently, the library receives one free copy of other state publications.

4. The bill increases the automatic free distribution of certain state documents to the Library of Congress.

# The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

LAW REVISION COMMITTEE PREFATORY NOTE: This bill is a remedial legislation proposal, requested by the department of public instruction and introduced by the law revision committee under s. 13.83 (1) (c) 4., stats. After careful consideration of the various provisions of the bill, the law revision committee has determined that this bill makes minor substantive changes in the statutes, and that these changes are desirable as a matter of public policy.

- **SECTION 1.** 35.82 (2) of the statutes is amended to read:
- 2 35.82 (2) The library of congress and the center for research libraries, Chicago,
- 3 Illinois <u>Council of State Governments, Lexington, Kentucky</u>, are designated as state
- 4 document depository libraries outside this state.
- 5 **SECTION 2.** 35.83 (3) (g) of the statutes is amended to read:
- 6 35.83 (3) (g) The center for research libraries, Chicago, Illinois Council of State
- 7 <u>Governments, Lexington, Kentucky</u>, one copy.

Note: The amendments in Sections 1 and 2 to provide that the Council of State Governments, rather than the Center for Research Libraries, will now be a depository to collect state documents. According to the reference and loan library, department of public instruction (DPI), the Council of State Governments took over this function in 1992, but the statutes have not been revised to reflect this change.

NOTE: The amendments in SECTIONS 7 and 8 provide that each selective state document depository library shall receive one copy of the Blue Book and one copy of agency biennial reports. According to the reference and loan library, DPI, this change reflects the intent that selective state depositories, which are designated by the division of library services, receive publications such as these which are of a general nature.
