2007 ASSEMBLY BILL 358

May 29, 2007 – Introduced by Representatives KLEEFISCH, NASS, ALBERS, DAVIS, GUNDERSON, HAHN, KERKMAN, LEMAHIEU, LOTHIAN, NERISON, SUDER, TOWNSEND and TURNER, cosponsored by Senators PLALE, GROTHMAN, ELLIS, KAPANKE, KEDZIE and OLSEN. Referred to Committee on Small Business.

1	AN ACT to renumber and amend 101.981 (1) (c); to amend 101.19 (1) (k),
2	101.983 (2) (c), 101.983 (2) (d) and 101.988 (3); <i>to create</i> 101.981 (1) (c) 4. and
3	101.981 (1) (c) 5. of the statutes; and $\textit{to affect}$ 2005 Wisconsin Act 456, section
4	7 (2) and 2005 Wisconsin Act 456, section 8 (intro.); relating to: exempting
5	residential lifts from the statutes regulating the installation and operation of
6	elevators and similar conveyances, rules implementing the statutes regulating
7	the installation and operation of elevators and similar conveyances, and
8	delaying the effective date for statutes regulating the installation and
9	operation of elevators and similar conveyances.

Analysis by the Legislative Reference Bureau

Under current law, the Department of Commerce (Commerce) regulates the installation, alteration, and operation of elevators, escalators, and similar conveyances that move people or things. Commerce is required to promulgate a safety code for installing and operating these conveyances. Beginning on June 1, 2007, contractors and mechanics installing, altering, and repairing these conveyances, and inspectors of these conveyances, must be licensed by Commerce, and, beginning on that date, these conveyances may not be installed, altered, or

operated unless Commerce has issued a permit authorizing the installation, alteration, or operation.

This bill excludes an elevator, dumbwaiter, stairway chair lift, or a similar lift that moves people and that is in a personal residence and a hoist used in construction from the definition of conveyance, thereby exempting these types of conveyances from the safety code and the licensing and permitting requirements described above.

The bill also delays, from June 1, 2007, to June 1, 2008, the date on which the licensing and permitting requirements described above take effect.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

"Conveyance" means an elevator, an escalator, a 10 dumbwaiter, a belt manlift, a moving walkway, a platform lift, a personnel hoist, a 11 material hoist and a stairway chair lift, and any other similar device, such as an 12 automated people mover, used to elevate or move people or things, as provided in the 13 rules of the department. "Conveyance" does not include <u>a any of the following:</u>

6	SECTION 5. 101.983 (2) (c) of the statutes, as created by 2005 Wisconsin Act 456,

8	101.983 (2) (c) Inspections. The department may not issue or renew a permit
9	under this subsection unless the department has received an inspection report for
10	the conveyance issued by an elevator inspector licensed under s. 101.985 (3)
11	indicating that the conveyance complies with this subchapter and any applicable
12	rules promulgated under this subchapter. Upon request of the owner of a private
13	residence containing a newly installed platform lift, stairway chair lift, or residential
14	lift or of the new owner of a private residence containing a previously installed
15	platform lift, stairway chair lift, or residential lift, the department shall inspect the
16	lift or equipment for compliance with this subchapter and any applicable rules
17	promulgated under this subchapter. This inspection by the department does not
18	exempt the owner from the requirement to ensure that the department receives an
19	inspection report from a licensed elevator inspector. Upon performing this
20	inspection, the department shall give the owner notice of relevant conveyance safety
21	requirements and shall instruct the owner as to the procedure for obtaining periodic
22	inspections and renewing the permit under which the lift or equipment is operated.

1	101.983 (2) (d) Term and posting requirements. A permit issued under this
2	subsection has a term of one year, except that a permit applicable to a platform lift,
3	stairway chair lift, or residential lift in a private residence is valid until ownership
4	of the private residence is transferred, at which time the new owner shall apply for
5	renewal of the permit under par. (b). The owner of the building or residence in which
6	a conveyance is located shall display the permit under par. (a) applicable to the
7	conveyance on or in the conveyance or, if applicable, in the machinery room.
8	SECTION 7. 101.988 (3) of the statutes, as created by 2005 Wisconsin Act 456,
9	is amended to read:
10	101.988 (3) PENALTIES. Any person who violates this subchapter or rules
11	promulgated under this subchapter may be fined not more than \$1,500 or imprisoned
12	for not more than 30 days or both , except that, notwithstanding s. 939.61 (1), the
13	owner of a private residence in which a conveyance is located may not be fined or
14	required to pay a forfeiture to this state as a result of any violation involving that
15	conveyance .

(1) (a) and (3) of the statutes, the department of commerce is not required to provide 1 $\mathbf{2}$ evidence that promulgating rules under this subsection as emergency rules is 3 necessary for the preservation of the public peace, health, safety, or welfare and is 4 not required to provide a finding of emergency for the rules promulgated under this 5 subsection. The department of commerce shall promulgate the rules required under 6 this subsection no later than the first day of the 9th month beginning after the 7 effective date of this subsection.
