Analysis by the Legislative Reference Bureau

With certain exceptions, current law prohibits a school district from beginning fall classes until September 1. Beginning in the 2014–15 school year, this bill eliminates this prohibition.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 118.045 of the statutes is repealed.
SECTION 2. 118.38 (1) (a) 8. of the statutes is repealed.
SECTION 3. 119.04 (1) of the statutes is amended to read:
