2013 ASSEMBLY BILL 336

August 23, 2013 – Introduced by Representatives Shankland, Billings, Bewley, Mason, Bernard Schaber, Sinicki, Berceau, Zepnick, Wright, C. Taylor, Young, Jorgensen, Ohnstad, Hebl, Milroy and Sargent, cosponsored by Senator Risser. Referred to Joint Committee on Finance.

AN ACT to amend 20.285 (1) (gb), 20.285 (1) (gb), 39.435 (8) and 39.435 (8); and to create 20.235 (1) (kd) of the statutes; relating to: funding for Wisconsin higher education grants for University of Wisconsin System students and making appropriations.

Analysis by the Legislative Reference Bureau

Under current law, \$58,345,400 is transferred from the University of Wisconsin (UW) System to the Higher Educational Aids Board (HEAB) and appropriated for Wisconsin higher education grants (WHEG grants) for UW System students in fiscal year 2013–14 and a sum sufficient of general purpose revenues are appropriated to HEAB for those grants in fiscal year 2014–15. This bill, in addition, transfers \$20,370,300 in each fiscal year from the UW System to HEAB and appropriates those moneys for WHEG grants for UW System students.
