



## 2013 ASSEMBLY BILL 624

January 15, 2014 - Introduced by Representatives GOYKE, JOHNSON, HULSEY, BERCEAU, HEBL, PASCH, ZEPNICK, KESSLER, SINICKI, OHNSTAD, BARNES and ZAMARRIPA, cosponsored by Senators HARRIS and L. TAYLOR. Referred to Committee on Housing and Real Estate.

1     **AN ACT to repeal** 16.40 (24) and 20.505 (1) (fz); and **to create** 16.40 (24) and  
2           20.505 (1) (fz) of the statutes; **relating to:** a grant to the city of Milwaukee to  
3           support the HOME GR/OWN program and making an appropriation.

### *Analysis by the Legislative Reference Bureau*

This bill makes a grant from general purpose revenues to the city of Milwaukee in the amount of \$2,000,000 for the purpose of supporting the city's HOME GR/OWN program to transform foreclosed properties into community assets that improve health and spark economic opportunity.

***The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:***

4           **SECTION 1.** 16.40 (24) of the statutes is created to read:  
5           16.40 (24) GRANT TO CITY OF MILWAUKEE FOR HOME GR/OWN PROGRAM. From  
6           the appropriation under s. 20.505 (1) (fz), provide a grant in the amount of \$2,000,000
