2013 SENATE BILL 485

January 10, 2014 – Introduced by Senators HARRIS and L. TAYLOR, cosponsored by Representatives Goyke, Johnson, Hulsey, Berceau, Hebl, Pasch, Zepnick, Kessler, Sinicki, Ohnstad, Barnes and Zamarripa. Referred to Committee on Insurance and Housing.

AN ACT to repeal 16.40 (24) and 20.505 (1) (fz); and to create 16.40 (24) and 20.505 (1) (fz) of the statutes; relating to: a grant to the city of Milwaukee to support the HOME GR/OWN program and making an appropriation.

Analysis by the Legislative Reference Bureau

This bill makes a grant from general purpose revenues to the city of Milwaukee in the amount of \$2,000,000 for the purpose of supporting the city's HOME GR/OWN program to transform foreclosed properties into community assets that improve health and spark economic opportunity.
