## **2015 ASSEMBLY BILL 275**

June 29, 2015 – Introduced by Representatives Kessler, Wachs, C. Taylor, Mason, HEBL, SUBECK and OHNSTAD, cosponsored by Senators C. Larson, Lassa and WIRCH. Referred to Committee on Judiciary.

1 AN ACT to amend 977.08 (4m) (c); and to create 977.08 (4m) (d) of the statutes; 2 relating to: increasing the rate paid to private attorneys for representing 3 indigent clients.

## Analysis by the Legislative Reference Bureau

This bill increases the hourly rate the state public defender (SPD) pays to private attorneys.

Under current law, the SPD provides legal representation for indigent persons in criminal, delinquency, and certain related cases. The SPD assigns cases either to staff attorneys or to local private attorneys. Generally, a private attorney who is assigned a case by the SPD is paid \$40 per hour for time spent related to the case and \$25 per hour for time spent in travel in certain situations.

This bill increases to \$85 per hour the amount a private attorney is paid for time spent related to the case.

**SECTION 1.** 977.08 (4m) (c) of the statutes is amended to read:
