## **2015 ASSEMBLY BILL 764**

January 20, 2016 – Introduced by Representatives TRANEL and NOVAK, cosponsored by Senator MARKLEIN. Referred to Committee on Jobs and the Economy.

1 AN ACT to repeal 20.505 (1) (fv); and to create 20.505 (1) (fv) of the statutes; 2 relating to: providing an economic development grant to Prosperity 3 Southwest Wisconsin and making an appropriation.

### Analysis by the Legislative Reference Bureau

This bill directs the Department of Administration to grant \$500,000 to Prosperity Southwest Wisconsin to fund a revolving loan program for the purpose of funding regional economic development and entrepreneurial start-ups. The bill transfers \$500,000 from the Wisconsin Economic Development Corporation's general programs and operations appropriation to the department for the purpose of administering the grant.

16	economic development and entrepreneurial start-ups.		
17	SECTION 5. Fiscal changes.		
18	(1) Economic development grant funds. In the schedule under section $20.005$		
19	(3) of the statutes for the appropriation to the Wisconsin Economic Development		
20	Corporation under section 20.192 $(1)$ $(a)$ of the statutes, as affected by the acts of		
21	2015, the dollar amount for fiscal year 2016–17 is decreased by \$500,000 for the		
22	purpose of administering the grant provided under SECTION 4 (1) of this act.
