2015 SENATE BILL 530

January 8, 2016 – Introduced by Senator MARKLEIN, cosponsored by Representatives TRANEL and NOVAK. Referred to Committee on Economic Development and Commerce.

1 AN ACT to repeal 20.505 (1) (fv); and to create 20.505 (1) (fv) of the statutes; 2 relating to: providing an economic development grant to Prosperity 3 Southwest Wisconsin and making an appropriation.

Analysis by the Legislative Reference Bureau

This bill directs the Department of Administration to grant \$500,000 to Prosperity Southwest Wisconsin to fund a revolving loan program for the purpose of funding regional economic development and entrepreneurial start-ups. The bill transfers \$500,000 from the Wisconsin Economic Development Corporation's general programs and operations appropriation to the department for the purpose of administering the grant.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 20.005 (3) (schedule) of the statutes: at the appropriate place, insert

15	revolving loan program in the southwest region of the state to promote regional			
16	economic development and entrepreneurial start-ups.			
17	SECTION 5. Fiscal changes.			
18	(1) ECONOMIC DEVELOPMENT GRANT FUNDS. In the schedule under section 20.005			
19	(3) of the statutes for the appropriation to the Wisconsin Economic Development			
20	Corporation under section 20.192 (1) (a) of the statutes, as affected by the acts of			
21	2015, the dollar amount for fiscal year 2016–17 is decreased by \$500,000 for the			
22	purpose of administering the grant provided under SECTION 4 (1) of this act.			
23	SECTION 6. Effective dates. This act takes effect on the day after publication,
