2017 ASSEMBLY BILL 237

April 13, 2017 – Introduced by Representatives RODRIGUEZ, PRONSCHINSKE, SNYDER, STEINEKE, BALLWEG, GENRICH, HORLACHER, JAGLER, KATSMA, KITCHENS, KRUG, MURSAU, NOVAK, PETRYK, RIPP, ROHRKASTE, SANFELIPPO, THIESFELDT, TITTL, TUSLER, VANDERMEER, SINICKI, E. BROOKS and KULP, cosponsored by Senators DARLING and OLSEN. Referred to Committee on Public Benefit Reform.

1 AN ACT *to create* 16.313 and 20.505 (7) (ft) of the statutes; **relating to:** grants 2 to municipalities to connect homeless individuals with permanent employment 3 and making an appropriation.

Analysis by the Legislative Reference Bureau

This bill creates a grant program under which the Department of Administration may award a grant of up to \$75,000 annually to a municipality for the purpose of connecting homeless individuals with permanent employment. A municipality receiving a grant under the program must itself contribute at least \$50,000 for the purpose of the grant. In awarding a grant under the bill, DOA must give preference to a municipality that obtains an agreement from a nonprofit organization to provide additional employment and support services to homeless individuals participating in the grant program.
