## 2017 ASSEMBLY BILL 52

- February 6, 2017 Introduced by Representatives THIESFELDT, ALLEN, BALLWEG, E. BROOKS, EDMING, MURSAU, SPIROS, STEFFEN, TUSLER, WICHGERS and SKOWRONSKI, cosponsored by Senators WANGGAARD and FEYEN. Referred to Committee on Judiciary.

the statutes; relating to: court proceedings for traffic violations.

## Analysis by the Legislative Reference Bureau

This bill eliminates references to an immediate trial for a person appearing in court in response to certain traffic citations.

Under current law, when a person appears in court in response to a traffic citation, the court is required to ask whether the person pleads guilty, not guilty, or no contest. If the person pleads not guilty, the person may ask the court for an immediate trial or request a continuance. This bill eliminates references to continuance and to immediate trial except for nonmoving traffic violations.

## The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

- **SECTION 1.** 345.34 (1) of the statutes is amended to read:

(1) If 7 Except as provided in this subsection, if the defendant pleads not guilty and requests 8 a continuance, the court shall set a future date for trial or advise the defendant that 9 notice will later be sent of the date set for trial. If the defendant appears in response to a nonmoving traffic violation under s. 345.28, the court may provide an immediate 10 11 trial. The court shall release the defendant if he or she posts an appearance bond, or the court may release the defendant on recognizance or without bail. A defendant 12 13not so released shall be committed to jail to await trial. 14**SECTION 4. Initial applicability.** 15(1) This act first applies to court proceedings commenced on the effective date
