2	Whereas, Representative Gannon was born on January 6, 1959, in Mequon,
3	Wisconsin, and passed away on October 3, 2017, at the age of 58; and
4	Whereas, Representative Gannon grew up in a large family with modest means
5	and worked to support himself and his family from an early age; and
6	Whereas, Representative Gannon graduated from West Bend East High School
7	in 1977; and
8	Whereas, Representative Gannon was proud to become a local business owner,
9	having served as a managing partner of Richards Insurance of West Bend, among
10	other business endeavors; and
11	Whereas, Representative Gannon demonstrated his lifelong commitment to
12	civic responsibility by assuming leadership roles within the West Bend Chamber of
13	Commerce, West Bend Economic Development Corporation, West Bend Sunrise
14	Rotary, West Bend Jaycees and Family Promise of Washington County; and

1 Whereas, Representative Gannon was a passionate champion of limited 2 government and fiscal responsibility, two of the causes he remained steadfastly 3 committed to following his election to the Wisconsin State Assembly in 2014; and 4 Whereas, Representative Gannon never hesitated to speak on behalf of his 5 constituents with candor and frankness; and 6 Representative Gannon served on the Assembly Urban Whereas. 7 Revitalization Committee as chair, the Assembly Children and Families Committee 8 as vice chair and various other committees; and 9 Whereas, Representative Gannon forged friendships with both former 10 competitors and colleagues across the aisle; and 11 Whereas, Representative Gannon was an outspoken conservative and advocate 12 for his party's principles; and 13 Whereas, Representative Gannon was a Christian who practiced his faith at 14 Still Waters United Methodist; and 15 Whereas, Representative Gannon was commonly referred to as "Mr. Wonderful," "Big Bad Bobby G." and "Insurance Agent Man," in addition to 16 "Gentleman from the 58th"; and 17 18 Whereas, Bob was a loving husband to Kris; father to Shanna and Bryce; 19 grandfather to Gavin; son to Thomas and Jane; and brother to nine siblings; now, 20 therefore, be it 21**Resolved by the assembly, the senate concurring, That** the legislature of 22 the state of Wisconsin honors the life and service of Robert "Bob" Gannon and extends 23 its heartfelt sympathies to his family, friends, colleagues and former constituents; 24and, be it further
