- Relating to: proclaiming January 2018 as human trafficking awareness and 1 $\mathbf{2}$ prevention month. 3 Whereas, according to the U.S. Department of Health and Human Services, human trafficking is a public health issue that impacts individuals, families, and 4 5 communities; and Whereas, human trafficking occurs when a person is recruited, harbored, 6 7 obtained, or transported through force, fraud, or coercion for the purposes of sexual exploitation, commercial sex acts, or labor exploitation; and 8 9 Whereas, human traffickers disproportionately target at-risk populations, 10 including individuals who have experienced or been exposed to other violence, such as child abuse and maltreatment and community violence, and those who are 11 12disconnected from stable support networks, such as runaway and homeless youth, 13unaccompanied minors, and persons displaced by natural disasters; and

1	Whereas, the U.S. State Department estimates that of the 600,000 to 800,000
2	people who are trafficked across international borders each year, 80 percent of all
3	trafficking victims are female and 50 percent of victims are children; and
4	Whereas, the average age a teen enters the sex trade in the U.S. is 12 to 14 years
5	old; and
6	Whereas, human trafficking has been reported in counties across the State of
7	Wisconsin, and it is a crime found in rural, urban, and suburban communities; and
8	Whereas, human trafficking is modern-day slavery, a practice that is in direct
9	opposition to the fundamental principles of liberty and human rights upon which our
10	nation was founded; and
11	Whereas, the State of Wisconsin is committed to eliminating human
12	trafficking, forming the Wisconsin Anti-Human Trafficking Task Force as a
13	partnership between the Wisconsin Department of Justice and the Wisconsin
14	Department of Children and Families to provide a cross-system, comprehensive,
15	trauma-informed service and response system in Wisconsin for minors who are
16	victims or at risk of being victims of sex trafficking; and
17	Whereas, the Wisconsin Anti-Human Trafficking Task Force has recently met
18	its goal of developing a coordinated and comprehensive plan to address the sex
19	trafficking of minors in Wisconsin; and
20	Whereas, to combat human trafficking in our state, our citizens must be aware
21	of the realities of human trafficking, educated to recognize victims of human
22	trafficking, and dedicated to stopping it; and
23	Whereas, a resolution passed by the United States Senate on June 22, 2007, has
24	forever marked January 11th as a day of awareness and vigilance for the countless
25	victims of human trafficking around the world; and

Whereas, eliminating human trafficking is a goal shared by all Americans who
 believe in freedom and liberty for all people; now, therefore, be it

Resolved by the assembly, the senate concurring, That: the members of the
Wisconsin Legislature proclaim January 2018 as Human Trafficking Awareness and
Prevention Month in the State of Wisconsin.
