## 2017 ASSEMBLY RESOLUTION 27

February 20, 2018 - Introduced by COMMITTEE ON RULES.

1     **Relating to:** establishing special orders of business for Thursday, February 22,

3     ***Resolved by the assembly, That:***

**SECTION 1. Special order scheduled.** The following proposals shall be
