2017 SENATE BILL 543

November 20, 2017 - Introduced by Senators DARLING, L. TAYLOR, CARPENTER, COWLES, FEYEN, JOHNSON, MOULTON, OLSEN, ROTH, STROEBEL, TESTIN and WIRCH, cosponsored by Representatives ROHRKASTE, FELZKOWSKI, RODRIGUEZ, NYGREN, KULP, MURSAU, TUSLER, DUCHOW, STEFFEN, R. BROOKS, HORLACHER, NOVAK, THIESFELDT, QUINN, E. 1 AN ACT *to create* 255.065 of the statutes; **relating to:** requiring facilities that 2 perform mammography examinations to provide notice to certain patients 3 regarding dense breast tissue and granting rule-making authority.

Analysis by the Legislative Reference Bureau

This bill requires a facility that performs mammography examinations to provide a notice containing specific information about breast density to patients with dense breast tissue. Federal law requires a facility that performs mammography examinations to provide a patient with a summary of the results of each mammography examination. The bill requires that the facility performing the mammography examination provide a patient determined to have dense breast tissue with a summary that includes a notice and specific information about dense breast tissue.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

- 4 **SECTION 1.** 255.065 of the statutes is created to read:

1	(a) "Dense breast tissue" means heterogeneously dense breasts or extremely
2	dense breasts based on the Breast Imaging Reporting and Data System established
3	by the American College of Radiology.
4	(b) "Facility" has the meaning given in 42 USC 263b (a) (3).
5	(c) "Mammography" has the meaning given in s. 255.06 (1) (b).
6	(2) A facility that performs mammography examinations shall, in delivering,
7	as required under 42 USC 263b (f) (1) (G) (ii) (IV), a summary of the results of any
8	mammography examination, provide to patients with dense breast tissue a notice
9	regarding breast density in substantially the following form:
10	BREAST DENSITY NOTIFICATION
11	Your mammogram shows that your breast tissue is dense. Dense breast tissue
12	is found in almost 40 percent of women and is a normal finding. However, studies
13	show that dense breast tissue can make it harder to find cancer on a mammogram
14	and is associated with a slightly increased risk of breast cancer. Regular screening
15	mammograms are still recommended for you. This information is provided to raise
16	your awareness about the result of your mammogram. You can use this information
17	to talk with your health care professional about your own risks for breast cancer.
18	Together, you can decide which screening options are right for you. The results of
19	your mammogram were sent to your doctor. Please note that breast density is
20	affected by several factors and may change over time.
21	(3) Nothing in this section may be construed to create a duty of care or other
22	legal obligation beyond the duty to provide notice as set forth in this section.
