2019 ASSEMBLY BILL 416

September 5, 2019 – Introduced by Representatives SUBECK, C. TAYLOR, ANDERSON, BILLINGS, EMERSON, KOLSTE, OHNSTAD, SINICKI and SARGENT, cosponsored by Senators LARSON, RISSER, JOHNSON and L. TAYLOR. Referred to Committee on Criminal Justice and Public Safety.

AN ACT *to amend* 941.29 (1g) (a), 941.291 (1) (b) and 973.123 (1); and *to create* 941.29 (3m) of the statutes; **relating to:** storage of a firearm in a house in which a resident is prohibited from possessing a firearm and providing a penalty.

Analysis by the Legislative Reference Bureau

This bill requires a person to store any firearm he or she possesses in a securely locked box or container or other secure locked location or with a trigger lock engaged if the person resides with a person who is prohibited from possessing a firearm under state law. A person who violates this requirement is guilty of a Class A misdemeanor for a first offense and a Class I felony for a second or subsequent offense.

Because this bill creates a new crime or revises a penalty for an existing crime, the Joint Review Committee on Criminal Penalties may be requested to prepare a report.
