



## 2019 ASSEMBLY BILL 680

December 16, 2019 - Introduced by Representatives KURTZ, MURSAU, DOYLE, EDMING, NOVAK, OLDENBURG, STUBBS, TRANEL, JAMES, WITTKE, MACCO, ROHRKASTE, SUBECK, PLUMER and STEFFEN, cosponsored by Senators JACQUE and OLSEN. Referred to Committee on Medicaid Reform and Oversight.

1     **AN ACT** *to amend* 49.45 (24k) (a) 1. and 2. and 49.45 (24k) (c) (intro.) and 3. of  
2             the statutes; **relating to:** expansion of the dental reimbursement pilot project  
3             under the Medical Assistance program.

### *Analysis by the Legislative Reference Bureau*

This bill expands statewide the dental reimbursement pilot project that, under current law, requires the Department of Health Services to distribute moneys to increase Medical Assistance reimbursement rates for pediatric dental care and adult emergency dental services provided in Brown, Marathon, Polk, and Racine Counties. Under the bill, DHS is required, subject to any necessary approval from the federal Department of Health and Human Services, to distribute moneys to increase statewide Medical Assistance reimbursement rates for pediatric dental care and adult emergency dental services.

14 maintenance organization that contracts with the department to provide Medical  
15 Assistance services at a capitated rate, the department shall distribute the  
16 reimbursement rate increase under subd. 1. to the health maintenance organization.  
17 The department shall include in a contract with a health maintenance organization

19 ~~1. a requirement that the health maintenance organization reimburse providers of~~

2 jurisdiction over health or public benefits under s. 13.172 (3), and the joint committee  
3 on finance that includes all of the following information on the pilot project under  
4 this subsection:

5 3. The feasibility of continuing the pilot project ~~and expanding the project in~~  
6 ~~specific areas of the state or statewide.~~
