2019 ASSEMBLY BILL 779

January 22, 2020 – Introduced by Representatives Allen, Kulp, Brandtjen, Duchow, Edming, Magnafici, Mursau, Pronschinske, Ramthun, Thiesfeldt, Wichgers, Gundrum, Skowronski, Loudenbeck, Felzkowski and Ballweg, cosponsored by Senators Petrowski, Nass and Kapenga. Referred to Committee on Education.

1 AN ACT to amend 118.133 (1) (a), 118.133 (1) (b) and 118.133 (2); and to create

- 2 118.133 (1) (c) of the statutes; **relating to:** participation in interscholastic
- 3 athletics and extracurricular activities.

Analysis by the Legislative Reference Bureau

This bill allows a pupil who attends a virtual charter school to participate in interscholastic athletics and extracurricular activities in the pupil's resident school district. The bill also provides that school districts are not allowed to be members of an interscholastic athletic association unless the association requires school district members to allow homeschooled pupils and virtual charter school pupils residing in a school district to participate in school district athletics.

Under current law, a school board must allow a homeschooled pupil who resides in the school district to participate in interscholastic athletics and extracurricular activities. Current law further provides that a school board may charge a homeschooled pupil a participation fee on the same basis that the school board charges participation fees to pupils enrolled in the school district. This bill extends these provisions to pupils who attend a virtual charter school. Under the bill, a school board may charge a virtual charter school pupil a participation fee on the same basis it charges participation fees to pupils enrolled in the school district. **ASSEMBLY BILL 779**
