## 2019 SENATE BILL 738

January 29, 2020 – Introduced by Senators FEYEN and CARPENTER, cosponsored by Representatives MURPHY, SKOWRONSKI and MILROY. Referred to Committee on Health and Human Services.

1	AN ACT to repeal 450.062 (intro.); to renumber $450.062$ (1) to (4); to renumber
2	$\textit{and amend} \ 450.09 \ (2); \textit{to amend} \ 450.06 \ (1), \ 450.06 \ (2) \ (b), \ 450.06 \ (2m), \ 450.09 \$
3	(1) (a) and 450.09 (2) (title); and <i>to create</i> 450.01 (21c), 450.02 (5) and 450.09
4	(2) (b) of the statutes; <b>relating to:</b> licensing and regulation of pharmacies and
5	remote dispensing sites under the pharmacy practice law, extending the time
6	limit for emergency rule procedures, providing an exemption from rule-making
7	procedures, and granting rule-making authority.

### Analysis by the Legislative Reference Bureau

Generally, under current law, no pharmacist may dispense at any location in this state that is not licensed as a pharmacy by the Pharmacy Examining Board, except that a pharmacist may, pursuant to rules promulgated by the board, dispense at certain specifically identified types of locations that are not licensed as pharmacies, which include health care facilities, health care provider offices or clinics, and jails and other adult and juvenile correctional or residential facilities.

This bill instead requires the aforementioned locations to be licensed by the board as pharmacies. As such, the bill requires that they adhere to a number of requirements that apply to other pharmacies, including the requirement for a managing pharmacist to be designated for the pharmacy. However, the bill allows pharmacies at any of those locations to be operated as remote dispensing sites, in

which case a pharmacist is not required to be present at the pharmacy, but in that case a pharmacist must remotely supervise the pharmacy. Finally, the bill allows the board to promulgate rules governing pharmacies operated as remote dispensing sites, which may exempt pharmacies operated as remote dispensing sites from rules that apply to other pharmacies.
