2021 SENATE BILL 564

September 15, 2021 - Introduced by Senators Wanggaard, Felzkowski, Johnson, Cowles, Darling, Jagler, Larson, Marklein, L. Taylor and Ballweg, cosponsored by Representatives Schraa, Callahan, Moore Omokunde, Baldeh, Bowen, Cabrera, Dallman, Dittrich, Drake, Goyke, Gundrum, Haywood, Horlacher, Knodl, L. Myers, Rozar, Sinicki, Spiros, Spreitzer, Tittl and Vining. Referred to Committee on Judiciary and Public Safety.

- 1 AN ACT to create 301.323 of the statutes; relating to: vendors at state correctional institutions.
 - Analysis by the Legislative Reference Bureau

This bill requires the Department of Corrections to contract with no fewer than three vendors to provide hobby, religious, and other personal property items for sale to inmates in state correctional institutions. Under the bill, DOC must allow an inmate, or a third party on behalf of an inmate, to purchase the items and must give inmates equal access to all vendors that DOC contracts with for this purpose. The bill also specifies that DOC must ensure that at least one of the vendors offers a storefront in the city of Milwaukee where a third party may place an order for items to be delivered to an inmate.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

- **Section 1.** 301.323 of the statutes is created to read:
- 301.323 Vendors of personal property items. (1) The department shall permit an inmate in a state correctional institution, or a 3rd party on behalf of an

inmate, to purchase department-approved hobby, religious, and other personal property items from a vendor that is contracted with under sub. (2). The department shall ensure that inmates have equal access to the approved items offered by each vendor, and the department may not give any preference to any contracted vendor. The department may not limit the items offered by a vendor based on the availability of the same or substantially similar items directly or indirectly through a canteen or other purchase option.

(2) Through a competitive bid for contractual services under s. 16.75, the department shall contract with not fewer than 3 vendors to provide department-approved hobby, religious, and other personal property items for purchase by an inmate in a state correctional institution or by a 3rd party on behalf of an inmate. Each vendor that is contracted with under this subsection shall allow for an inmate, or a 3rd party on behalf of an inmate, to purchase the approved items from a catalogue and through an online Internet site. The department shall ensure that at least one of the vendors allows a 3rd party, on behalf of an inmate, to place in-person orders for approved personal, hobby, and religious items at a storefront in a first-class city.

Section 2. Nonstatutory provisions.

(1) The department of corrections shall complete all activities that it determines are necessary to implement s. 301.323 no later than 30 days after the effective date of this subsection.
