Analysis by the Legislative Reference Bureau

This bill provides additional funding to the Technical College System for state aid and grants to technical colleges.

The bill also provides additional funding for special education aid the Department of Public Instruction pays to school districts, independent charter schools, cooperative educational service agencies, and county children with disabilities education boards, for purposes of maintaining compliance with maintenance of effort requirements of the federal Consolidated Appropriations Act and the federal American Rescue Plan Act.

purpose for which the appropriation is made and the dollar amount for fiscal year
2022-23 is increased by \$9,750,000 to increase funding for the purpose for which the

appropriation to the department of public instruction under s. 20.255 (2) (b), the
dollar amount for fiscal year 2021-22 is increased by \$13,900,000 to increase funding
for aids for special education under s. 115.88 and the dollar amount for fiscal year
2022-23 is increased by \$13,900,000 to increase funding for aids for special
education under s. 115.88.
