2021 SENATE BILL 879

January 21, 2022 – Introduced by Senators SMITH, ROYS and L. TAYLOR, cosponsored by Representatives SUBECK, VINING, ANDRACA, CONSIDINE, EMERSON, HEBL, HONG, POPE, SHELTON, SINICKI, SPREITZER, STUBBS and VRUWINK. Referred to Committee on Human Services, Children and Families.

1 AN ACT *to create* 20.437 (1) (dm) and 48.483 of the statutes; **relating to:** 2 scholarships for sibling connections and making an appropriation.

Analysis by the Legislative Reference Bureau

This bill requires the Department of Children and Families to provide scholarships to adopted children and their biological siblings who do not reside in the same household to attend programs together in order to build sibling connections.

The bill also provides additional funding for the University of Wisconsin and for special education aid the Department of Public Instruction pays to school districts, independent charter schools, cooperative educational service agencies, and county children with disabilities education boards, for purposes of maintaining compliance with maintenance of effort requirements of the federal Consolidated Appropriations Act and the federal American Rescue Plan Act.
