2023 ASSEMBLY BILL 418

September 19, 2023 – Introduced by Representatives ROZAR, ARMSTRONG, BALDEH, CONLEY, EDMING, OHNSTAD, OLDENBURG, ORTIZ-VELEZ, PALMERI, PETRYK, SHANKLAND, SINICKI, STEFFEN, STUBBS and SUBECK, cosponsored by Senators FEYEN and QUINN. Referred to Committee on Health, Aging and Long-Term Care.

1 AN ACT relating to: healthy aging grants and making an appropriation.

Analysis by the Legislative Reference Bureau

This bill directs the Department of Health Services to allocate as a grant \$378,000 in each fiscal year of the 2023-25 fiscal biennium to a private, nonprofit entity that conducts certain activities related to healthy aging, including coordinating the implementation of evidence-based health promotion programs to support healthy aging; serving as a statewide clearinghouse on evidence-based falls injury, disease prevention, self-management, and health promotion programs; providing training and technical assistance to the staff of county departments, administering agencies, and other providers of services to aging populations; and collecting and disseminating information on falls injury, disease prevention, and health promotion in healthy aging populations.

(a) Implementing and coordinating efforts to reduce older adult falls through
the Falls Free Wisconsin initiative to raise awareness of falls prevention strategies,
provide tools and resources to reduce falls, and support local falls prevention
initiatives with a focus on partnerships between aging services, public safety
services, and health care providers to reduce the burden and costs.

SECTION 2. Fiscal changes.

(1) HEALTHY AGING GRANT. In the schedule under s. 20.005 (3) for the
appropriation to the department of health services under s. 20.435 (1) (a), the dollar
amount for fiscal year 2023-24 is increased by \$378,000 and the dollar amount for
