2023 ASSEMBLY BILL 827

December 22, 2023 - Introduced by Representatives MYERS, JOERS, JACOBSON, PALMERI, ANDRACA, BALDEH, CLANCY, CONLEY, CONSIDINE, DRAKE, J. ANDERSON, MADISON, MOORE OMOKUNDE, NEUBAUER, RATCLIFF, SHELTON, SINICKI, EMERSON, SUBECK, STUBBS and ORTIZ-VELEZ, cosponsored by Senators CARPENTER, AGARD, SMITH, HESSELBEIN, L. JOHNSON, LARSON, ROYS, SPREITZER, TAYLOR and PFAFF. Referred to Committee on Energy and Utilities.

1 **AN ACT** *to amend* 119.04 (1); and *to create* 20.255 (2) (dv) and 115.457 of the
2 statutes; **relating to:** an energy efficiency grant program for school districts,
3 granting rule-making authority, and making an appropriation.

Analysis by the Legislative Reference Bureau

This bill creates a \$10,000,000 per year grant program under which the Department of Public Instruction must award grants to school districts for energy efficiency projects in school buildings. For the first two school years of the grant program, DPI must give preference in awarding grants to projects that relate to heating, ventilation, and air conditioning systems. DPI may promulgate rules to implement the grant program.
