2023 SENATE BILL 55

- February 14, 2023 Introduced by Senators JAMES, L. JOHNSON, AGARD, BALLWEG, COWLES, FELZKOWSKI, HESSELBEIN, LARSON, ROYS, SMITH, SPREITZER, TAYLOR and WIRCH, cosponsored by Representatives KITCHENS, BILLINGS, J. - AN ACT to amend 51.20 (13) (cr), 165.76 (1) (am), 938.34 (15) (a) 1., 944.30 (1m) (intro.), 944.30 (2m) and 973.015 (2m) (intro.) of the statutes; relating to: prosecuting or adjudicating delinquent a person under the age of 18 for committing an act of prostitution.

Analysis by the Legislative Reference Bureau

Under current law, a person who is under the age of 18 may be prosecuted or adjudicated delinquent for committing an act of prostitution, a Class A misdemeanor. Under this bill, a person who is under the age of 18 may not be prosecuted or adjudicated delinquent for committing an act of prostitution. This bill also eliminates the option under current law in cases where a person under the age of 18 has committed an act of prostitution for a court to enter a consent decree under the Juvenile Justice Code, or a deferred prosecution agreement under the Juvenile Justice Code or adult criminal statutes, if the court determines that a consent decree or deferred prosecution agreement will serve the best interests of the person being prosecuted and will not harm society.

18	of s. 940.225 (3m), 941.20 (1), 944.20, 944.30 (1m), 944.31 (1), 944.33, 946.52, or
19	948.10(1) (b), the court shall require the juvenile to comply with the requirement
20	under s. 165.76 (1) (am) by providing a biological specimen to the state crime

13	adjudication, or finding, or may order that the record of the violation of s. 944.30 be
