1	Relating to: recognizing and commending the National Conference of State
2	Legislatures on its 50th anniversary in 2025.
3	Whereas, the National Conference of State Legislatures was founded in 1975
4	and has evolved during the past half-century to become the premier organization
5	solely dedicated to serving state and territorial legislators and legislative staff; and
6	Whereas, NCSL was created from the merger of three organizations that served
7	or represented state legislatures and that shared the belief that legislative service
8	is one of democracy's worthiest pursuits; and
9	Whereas, NCSL is a bipartisan organization with three objectives: to advance
10	the effectiveness, independence and integrity of state legislatures; to foster
11	interstate communication and cooperation; and to ensure states a strong, cohesive
12	voice in the federal system; and
13	Whereas, our nation's state legislatures are laboratories of democracy and have
14	continuously shown that they are capable of tackling emerging challenges; and

1	Whereas, state legislatures are where people from different backgrounds,
2	representing different communities, can come together and find common ground;
3	and
4	Whereas, NCSL has facilitated the exchange of ideas, provided critical research
5	and information, and encouraged a rigorous review of complex issues confronting our
6	communities, states, and nation; and
7	Whereas, NCSL strives to strengthen the bonds between America's state
8	legislatures and the international community; and
9	Whereas, the Wisconsin Legislature has played an active role in NCSL since the
10	organization's founding; and
11	Whereas, in 1975, Legislative Council Director Bonnie Reese became the first
12	NCSL Staff Chair from Wisconsin and was followed by multiple staff chairs from
13	Wisconsin including State Auditor Dale Cattanach in 1985–86, Senate Chief Clerk
14	Donald Schneider in 1992–93, and Legislative Reference Bureau Chief Steve Miller
15	in 2006–07; and, in 2019, Assembly Speaker Robin Vos was elected as the first NCSL
16	President from Wisconsin; and
17	Whereas, Speaker Vos currently serves as NCSL President Emeritus, and
18	Legislative Council Director Anne Sappenfield serves as NCSL Immediate Past Staff
19	Chair; and
20	Whereas, Assembly Majority Leader Tyler August and the Legislative
21	Reference Bureau's Administrative Services Manager Wendy Jackson currently
22	serve on the NCSL Executive Committee; now, therefore, be it
23	Resolved by the senate, the assembly concurring, That the members of the
24	Wisconsin State Legislature recognize and commend the National Conference of
