# **2025 ASSEMBLY BILL 128**

March 11, 2025 - Introduced by Representatives Krug, Behnke, Callahan, Kaufert, Kreibich, Melotik, Miresse, Mursau, Ortiz-Velez, Palmeri, Subeck and Wichgers, cosponsored by Senators Testin, Jacque, Cabral-Guevara and L. Johnson. Referred to Committee on Health, Aging and Long-Term Care.

- 1 AN ACT to create 255.075 of the statutes; relating to: requiring first
- 2 responders to be trained to administer epinephrine delivery systems.

### Analysis by the Legislative Reference Bureau

This bill requires first responders to be trained in how to recognize signs and symptoms of severe allergic reactions, standards and procedures for the storage and administration of an epinephrine delivery system, and emergency follow-up procedures after an epinephrine delivery system is administered and requires first responders to have an epinephrine delivery system available to the first responder for use at all times while on duty. First responders include conservation wardens, correctional officers, emergency medical responders, emergency medical services practitioners, firefighters, and law enforcement officers. The Department of Health Services is required to identify organizations that conduct trainings that cover all the subjects that first responders are required to be trained in under the bill. Finally, the bill allows DHS to distribute epinephrine delivery systems to first responders who are trained in all subjects described under the bill to be used by those first responders.

- (c) Emergency follow-up procedures after an epinephrine delivery system is administered.
  - (4) Each first responder shall have an epinephrine delivery system available to the first responder for use at all times while on duty.
  - (5) From the appropriation under s. 20.435 (1) (a), the department may distribute epinephrine delivery systems to first responders who are trained in all subjects described under sub. (3) or to employers of first responders who are trained in all subjects described under sub. (3) to be administered by those first responders.
