## 2025 ASSEMBLY BILL 388

August 27, 2025 - Introduced by Representatives MOSES, HURD, SUMMERFIELD, ARMSTRONG, BRILL, CALLAHAN, DITTRICH, DUCHOW, KREIBICH, MAXEY, MURSAU, NOVAK, SNYDER and TUCKER, cosponsored by Senators JAMES, QUINN, SMITH, DASSLER-ALFHEIM, MARKLEIN, TESTIN and TOMCZYK. Referred to Committee on Mental Health and Substance Abuse Prevention.

- 2     **relating to:** grant program for an integrated mental health facility.

### *Analysis by the Legislative Reference Bureau*

This bill requires the Department of Health Services to award a onetime grant to Rogers Behavioral Health during fiscal year 2025-26 to construct and build an integrated mental health facility in the Chippewa Valley region of the state that includes a crisis stabilization unit, residential treatment center, partial hospitalization/intensive outpatient program, and supportive living to provide adolescents and adults with a full continuum of care for mental health issues. DHS may award the grant only if Rogers Behavioral Health submits both a letter of intent to use any grant awarded for constructing and building an integrated mental health facility as described in the bill and proof of purchase or lease of land. The bill establishes a new appropriation account to which an appropriation may be made to support this grant.

**SECTION 1.** 20.005 (3) (schedule) of the statutes: at the appropriate place,

**SECTION 2.** 20.435 (5) (bk) of the statutes is created to read:

20.435 (5) (bk) *Integrated mental health facility grant program.* The amounts  
in the schedule for an integrated mental health facility grant under 2025 Wisconsin  
Act .... (this act), section 4 (1).

**SECTION 3.** 20.435 (5) (bk) of the statutes, as created by 2025 Wisconsin Act  
.... (this act), is repealed.

**SECTION 4. Nonstatutory provisions.**

(1) INTEGRATED MENTAL HEALTH FACILITY GRANT PROGRAM.

(a) In fiscal year 2025-26, the department of health services shall, subject to  
par. (b), award a onetime grant to Rogers Behavioral Health to construct and build  
an integrated mental health facility in the Chippewa Valley region of this state that  
includes a crisis stabilization unit, residential treatment center, partial  
hospitalization/intensive outpatient program, and supportive living to provide  
adolescents and adults with a full continuum of care for mental health issues.

(b) The department of health services shall award a grant under par. (a) only  
if Rogers Behavioral Health submits to the department a letter of intent to use any

3 **SECTION 5. Effective dates.** This act takes effect on the day after
